1. IN CHECKING MY CHRONO FILE AND MY MEMORY, I CAN NOT REPEAT CAN NOT FIND ANY EVIDENCE I WAS INFORMED OF THE LAVI BROTHERS BEING ON A BLACKLIST PRIOR TO MAY 1975. I DEFINITELY KNOW OF NO EVIDENCE THAT THE MAAG WAS IN RECEIPT OF THE DOCUMENTS ON THE LAVI BROTHERS PRIOR TO RECEIVING THEM FROM HENRY PRECHT ON 20 JULY 1975.

2. AS YOU ARE AWARE, THE SUBJECT OF AGENTS AND AGENTS' FEE CONSTANTLY CROPPED UP THROUGHOUT MY TOUR. THEREFORE, IT IS POSSIBLE THE LAVI BROTHERS COULD HAVE BEEN LUMPED IN WITH OTHERS PRIOR TO MAY 1975, WITH OUT MY NOTICING IT.

3. I DO HAVE A XEROX FILE COPY OF WHAT MAY BE THE MOST SIGNIFICANT: AN EMB FORM 35 ROUTING SLIP, DTD JULY 20, 1975, FROM HENRY PRECHT WITH THIS TYPED NOTE: QUOTE ATTACHED DOCUMENTS ON THE LAVI BROTHERS PROVIDED BY GEN TOUFANIAN ON JULY 16, 1975. UNQUOTE THE ATTACHMENT US A 6 NOV 72 DOCUMENT FROM TOUFANIAN TO CHIEF, SUPREME COMMANDER'S STAFF; UNDOUBTEDLY THE SAME 6 NOV 72 DOCUMENT YOU LIST IN YOUR 10 FEB MESSAGE. TO ME THIS INDICATES THAT TOUFANIAN PASSED YOU A COPY OF HIS LETTER ON JULY 16, 1975, NOT NECESSARILY IN 1972. THE DISTRIBUTION ON THE TOUFANIAN DOCUMENT, WRITTEN IN ENGLISH BY A FOREIGN HAND, IS LISTED AS: QUOTE CHIEF, SCS AND THE CNC, IIGF, IIAF, IIN, IIG, II NATIONAL POLICE. UNQUOTE
