Dear Ms. Ayers:

Thank you for your letter of October 5, 2007, submitting the percentage allocations among the Community Development Quota (CDQ) groups for the portion of the CDQ reserves that are created by the allocation of 0.7 percent of certain groundfish total allowable catch (TAC) limits to the CDQ Program. The Western Alaska Community Development Association (WACDA) submitted these percentage allocations, acting in its capacity as the CDQ administrative panel under section 303(i)(1)(C)-of the Magnuson-Stevens Fishery Conservation and Management Act.

Beginning in 2008, the CDQ Program will receive 10.7 percent of certain Bering Sea and Aleutian Islands groundfish TACs as CDQ reserves. The primary portion of each reserve (10 percent of the TAC) will be allocated among the six CDQ groups based on the percentage allocations that were in effect on March 1, 2006. The balance of each reserve (0.7 percent of the TAC) will be allocated among CDQ groups based on WACDA's percentage allocations. Table 1 shows the percentage allocations of each CDQ reserve as they will be apportioned among the six CDQ groups.

NMFS will create a single allocation of each CDQ reserve to each CDQ group that is allocated a portion of that CDQ reserve. The single allocation will be made up of the amount of quota allocated to the CDQ group from both portions of the CDQ reserve (10 percent of the TAC and 0.7 percent of the TAC). We will send you a table showing the amount of each CDQ reserve that is allocated to each CDQ group once information about the final 2008 TACs and CDQ reserves are available.
