The Employment Development Department offers the following electronic methods of filing and paying payroll tax reports.



Online Services

DE 6 Quarterly Wage and Withholding Report
DE 542 Report of Independent Contractors
DE 34 Report of New Employees



Telefile

Small employers may file their DE 6 Quarterly Wage and Withholding reports and pay their taxes by telephone.



Electronic Funds Transfer

Pay your Unemployment Insurance, Employment Training Tax, State Disability, and Personal Income Tax Withholding by transferring funds from your bank account to the State's account.



EZPAY

Tax deposits are charged to your major credit card.

Magnetic Media

Employers who are required to file their federal wage reports on magnetic media must also file their Quarterly Wage and Withholding Reports (DE 6) on magnetic media.

This electronic method is also available to all employers, tax preparers, and payroll services for the following reports:

- DE 6 Quarterly Wage and Withholding Report
- DE 542 Report of Independent Contractors
- DE 34 Report of New Employees
- DE 7 Annual Reconciliation Report and DE 88 Payroll Tax Deposits Available to Tax Preparers and Payroll Services.
