Unneutered or unspayed dog, cat, ferret	\$10.00
Unneutered or unspayed dog, cat, ferret owned by a person 62 or older	\$ 4.00
Neutered or spayed dog, cat, ferret	\$ 2.00

An Animal License is required by the Bernalillo County Ordinance (#99-4, Section 6-43) for any dog, cat, or ferret over the age of three months. In addition, a current rabies certificate and proof of sterilization (if applicable) must be presented at the time of applying for a license. Only a licensed veterinarian can provide proof of sterilization for a sterilized animal.

The Animal License must be renewed each year.

GENERAL INFORMATION

A completed application must include: animal license application including signature and date, current rabies certificate for each animal, proof of sterilization (if applicable) and payment. Payment may be cash, money order, or check payable to Bernalillo County Treasurer. An incomplete application will be returned.
