## HOUSE CONCURRENT RESOLUTION

REQUESTING A STUDY ON THE ESTABLISHMENT OF AN INDEPENDENT STATE CIVIL DEFENSE AGENCY.

1 2 3 4 5 6	WHEREAS, the main mission of the State Department of Defense is "[t]o maintain readiness to respond to the needs of the people in the event of disasters, either natural or human- caused", according to the <u>Multi-Year Program and Financial Plan</u> and Executive Budget; and
7 8 9	WHEREAS, the Department is headed by a military commander and not a civilian public officer; and
9 10 11 12 13 14	WHEREAS, to perform its mission, the Department has four divisions: the Hawaii Army National Guard, the Air National Guard, the Hawaii State Defense Force, and the State Civil Defense; and
14 15 16 17 18	WHEREAS, the first three are military divisions, the duties of which include responding to federal orders during times of war or national emergency; and
19 20 21 22	WHEREAS, the Civil Defense Division is a civilian organization that prepares for and responds to natural disasters and other emergencies; and
23 24 25 26	WHEREAS, there is increasing sentiment that the Department of Defense places its primary focus on its military duties and responsibilities to the detriment of the Civil Defense Division; and
27 28 29 30 31 32	WHEREAS, because of the secondary focus on the Civil Defense Division, the Department has been criticized as not having sufficient plans and equipment to adequately respond to the various types of natural disasters and emergencies and protect the public; and

1 WHEREAS, one often discussed structural change to resolve 2 the problem is the separation of the Civil Defense Division from 3 the Department of Defense; and 4 5 WHEREAS, such a structural change requires study to 6 determine if it should be implemented; now, therefore, 7 8 9 BE IT RESOLVED by the House of Representatives of the Twenty-fourth Legislature of the State of Hawaii, Regular 10 Session of 2008, the Senate concurring, that the Auditor is 11 requested to conduct a study of separating the Civil Defense 12 Division from the supervision and control of the Department of 13 14 Defense and upgrading the Division to an independent agency, the head of which shall report directly to the Governor; and 15 16 17 BE IT FURTHER RESOLVED that the Auditor is requested to submit the study to the Legislature at least twenty days prior 18 to the convening of the Regular Session of 2009; and 19 20 BE IT FURTHER RESOLVED that certified copies of this 21 22 Concurrent Resolution be transmitted to the Governor, the Adjutant General, the Vice Director of Civil Defense, and the 23 Auditor. 24 25 26 27 Cabrie &
