A BILL FOR AN ACT

RELATING TO WORKERS' COMPENSATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. (a) There is established a working group on
 funding for workers' compensation independent medical
 examinations, to be placed under the department of labor and
 industrial relations for administrative purposes.

5 (b) The purpose of the working group on funding for 6 workers' compensation independent medical examinations shall be to study and determine the alternative methods or combination of 7 8 methods of paying impartial physicians to conduct medical 9 examinations pursuant to section 386-80, Hawaii Revised 10 Statutes. The study shall be undertaken with a view toward 11 providing equity and fairness in funding independent medical 12 examinations, so that the employer, employer's insurer, special 13 compensation fund, and state general fund are not 14 disproportionately burdened or otherwise disadvantaged in paying 15 for the examinations.

16 (c) The working group on funding for workers' compensation17 independent medical examinations shall be composed of one


