## HOUSE RESOLUTION

DESIGNATING MAY 5 THROUGH MAY 9, 2008, AS HAWAII TEEN DATING VIOLENCE AWARENESS AND PREVENTION WEEK.

1 2 3	WHEREAS, one in three female teenagers in a dating relationship has feared for her physical safety; and
4 5 6	WHEREAS, one in two teenagers in a serious relationship has compromised personal beliefs to please a partner; and
7 8 9	WHEREAS, one in five teenagers in a serious relationship reports having been hit, slapped, or pushed by a partner; and
10 11 12 13	WHEREAS, twenty-seven per cent of teenagers have been in dating relationships in which their partners called them names or "put them down"; and
14 15 16	WHEREAS, twenty-nine per cent of girls who have been in a relationship said that they have been pressured to have sex or to engage in sexual activities that they did not want; and
17 18 19 20	WHEREAS, technologies such as cell phones and the Internet have made dating abuse both more pervasive and more hidden; and
21 22 23 24 25	WHEREAS, thirty per cent of teenagers who have been in a dating relationship say that they have been text-messaged between ten and thirty times per hour by a partner seeking to find out where they are, what they are doing, or who they are with; and
26 27 28 29 30 31	WHEREAS, seventy-two per cent of teenagers who reported they had been checked up on by a boyfriend or girlfriend ten times or more per hour by email or text messaging did not tell their parents; and
31 32 33 34	WHEREAS, parents are largely unaware of the cell phone and internet harassment experienced by teenagers; and

WHEREAS, cultural, linguistic, socioeconomic, and political 1 barriers prevent Asian women from seeking help in abusive 2 situations; and 3 4 WHEREAS, seven domestic violence related homicides were 5 reported in 2000 in Hawaii, with a disproportionately high rate 6 of those women being of Filipino descent; and 7 8 9 WHEREAS, violent relationships in adolescence can have serious ramifications for victims, putting them at higher risk 10 for substance abuse, eating disorders, risky sexual behavior, 11 suicide, and adult revictimization; and 12 13 14 WHEREAS, the severity of violence among intimate partners has been shown to be greater in cases where the pattern of 15 violence has been established in adolescence; and 16 17 WHEREAS, the establishment of Hawaii Teen Dating Violence 18 Awareness and Prevention Week will benefit schools, communities, 19 and families regardless of socioeconomic status, race, or sex; 20 21 now, therefore, 22 BE IT RESOLVED by the House of Representatives of the 23 Twenty-fourth Legislature of the State of Hawaii, Regular 24 Session of 2008, that this body designates the week of May 5 25 through May 9, 2008, as "Hawaii Teen Dating Violence Awareness 26 and Prevention Week"; and 27 28 BE IT FURTHER RESOLVED that the Legislature calls upon the 29 30 people of Hawaii, high schools, law enforcement, state and local officials, and interested groups to observe Hawaii Teen Dating 31 Violence Awareness and Prevention Week with appropriate programs 32 and activities that promote awareness and prevention of the 33 crime of teen dating violence in their communities; and 34 35 BE IT FURTHER RESOLVED that certified copies of this 36 Resolution be transmitted to the Governor, the Superintendent of 37 Education, the President of the University of Hawaii, the 38
