

SENATE CONCURRENT RESOLUTION

REQUESTING THE AUDITOR TO CONDUCT A FINANCIAL AND MANAGEMENT AUDIT OF THE ADULT MENTAL HEALTH DIVISION OF THE DEPARTMENT OF HEALTH.

WHEREAS, the Adult Mental Health Division of the Department 1 of Health seeks to improve the mental health of Hawaii's people 2 by reducing the prevalence of emotional disorders and mental 3 illness; and 4 5 WHEREAS, services include mental health education, 6 treatment, and rehabilitation through community-based mental 7 health centers; and 8 9 WHEREAS, there are nine community health centers in Hawaii 10 that provide mental health services; and 11 12 WHEREAS, of the State's nine community health centers, Hale 13 Na'au Pono is the only private nongovernmental organization, the 14 other eight operate under the Department of Health; and 15 16 WHEREAS, chapter 103F, Hawaii Revised Statutes, establishes 17 procedures for the purchases of health and human services 18 through contracts made by state agencies; and 19 20 WHEREAS, contracts made by state agencies should be issued 21 in an equitable manner and should follow established rules and 22 procedures; now, therefore, 23 24 BE IT RESOLVED by the Senate of the Twenty-fourth 25 Legislature of the State of Hawaii, Regular Session of 2008, the 26 House of Representatives concurring, that the Auditor is 27 requested to conduct a financial and management audit of the 28 Adult Mental Health Division of the Department of Health; and 29 30 BE IT FURTHER RESOLVED that the Auditor is requested to 31 include in the financial and management audit: 32
