## SENATE CONCURRENT RESOLUTION

URGING THE UNIVERSITY OF HAWAII AND SUPPORTING COMMUNITY MEMBERS TO MOVE EXPEDITIOUSLY TO IMPLEMENT PLANS FOR THE CONSTRUCTION OF THE CANCER RESEARCH CENTER OF HAWAII AT KAKAAKO.

WHEREAS, the University of Hawaii's (UH's) Cancer Research 1 Center of Hawaii (Center) is one of 61 National Cancer Institute 2 (NCI)-designated cancer centers in the United States; and 3 4 WHEREAS, NCI designation is a highly coveted distinction, 5 6 awarded after a rigorous review of the breadth, depth, and quality of a center's research programs; and 7 8 WHEREAS, NCI-designated cancer centers include large and 9 well-known facilities such as the M.D. Anderson Cancer Center in 10 Houston and the Fred Hutchinson Cancer Research Center in 11 Seattle, as well as other entities that can be considered peers 12 of UH, such as the Universities of Alabama, Nebraska, and New 13 Mexico; and 14 15 WHEREAS, NCI-designated centers have become magnets for 16 cancer research funding, and collectively receive two-thirds of 17 all NCI research grants and contracts; and 18 19 WHEREAS, NCI-designated centers with a clinical care 20 component represent the centers of excellence for cancer care in 21 the regions they serve due to the high quality of their faculty 22 and their access to innovative clinical trials and transitional 23 research protocols; and 24 25 WHEREAS, our state, with its rapidly increasing aging 26 population, will be faced with an ever-growing number of cancer 27 patients in the foreseeable future: currently there are 28 approximately 5,500 new cancer cases in Hawaii each year, and 29

WHEREAS, the UH Board of Regents has approved the 1 construction of new facilities for the Center adjacent to the 2 John A. Burns School of Medicine in Kakaako to provide expanded 3 facilities for research programs and to house a state-of-the-art 4 cancer care facility; and 5 6 WHEREAS, the 2006 Legislature, recognizing the importance 7 of state support for the Center, directed a portion of the state 8 tax on cigarettes to be deposited into the Hawaii Cancer 9 Research Special Fund for the Center's research and operating 10 expenses; and 11 12 WHEREAS, key participants in the region, including those 13 involved in cancer care, cancer research, and clinical trials, 14 have spent considerable time and effort in planning for the 15 development of the Center; now, therefore, 16 17 BE IT RESOLVED by the Senate of the Twenty-fourth 18 19 Legislature of the State of Hawaii, Regular Session of 2008, the House of Representatives concurring, that the University of 20 Hawaii and supporting members of the community are urged to move 21 forward as expeditiously as possible to implement the plans that 22 have been developed for construction of the Cancer Research 23 Center of Hawaii at Kakaako; and 24 25 BE IT FURTHER RESOLVED that certified copies of this 26 Concurrent Resolution be transmitted to the Chairperson of the 27 University of Hawaii Board of Regents, the President of the 28 University of Hawaii, the Chancellor of the University of Hawaii 29 at Manoa, and the Vice President for Research of the University 30 of Hawaii. 31 32 33 34
