## SENATE CONCURRENT RESOLUTION

REQUESTING THE DIRECTOR OF COMMERCE AND CONSUMER AFFAIRS TO ESTABLISH A PRE-NEED FUNERAL INDUSTRY ADVISORY COMMITTEE TO PROVIDE INPUT ON CONCERNS AND SOLUTIONS REGARDING THE PRE-NEED FUNERAL INDUSTRY.

WHEREAS, the residents of Hawaii are provided funeral 1 services by approximately twenty companies of which the majority 2 3 offer pre-need funeral plans; and 4 WHEREAS, pre-need funeral plans provide consumers the 5 ability to pre-arrange their funerals in order to relieve their 6 family members of the trouble of making funeral arrangements at 7 the time of their death; and 8 9 WHEREAS, there are more than 100,000 people in Hawaii who 10 have purchased a pre-need funeral plan with a total value of 11 more than \$150,000,000, which is held in trust; and 12 13 WHEREAS, recent incidents of questionable practices by 14 Memorial Mortuary have led to a settlement to repay a total of 15 \$150,000 to customers who bought pre-need funeral services from 16 17 Memorial Mortuary; and 18 WHEREAS, furthermore, public concerns regarding Honolulu 19 Memorial Park have alleged mismanagement and failure to fulfill 20 promises to restore the aging cemetery; and 21 22 WHEREAS, ongoing proceedings have alleged that the trustees 23 of RightStar properties, which include the Valley of the 24 Temples, Homelani, Kona, and Maui Memorial Parks, have 25 improperly removed approximately \$30,000,000 from the company's 26 pre-need funeral plan trust funds; and 27 28 WHEREAS, the existing monitoring system for the cemetery 29 and pre-need funeral industry, which currently only requires the 30 submission of annual actuarial and financial reports, is not
