A BILL FOR AN ACT

RELATING TO INSURANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Section 286-108.4, Hawaii Revised Statutes, is amended to read as follows:

 "[+]§286-108.4 Driver education and behind-the-wheel
- 4 driver training program.[]] The director of transportation is
- 5 directed to establish and certify a statewide driver education
- 6 program and behind-the-wheel driver training program, to include
- 7 the number of course hours, curriculum, and certification of
- 8 teachers and third-party examiners[-], and an optional accident
- 9 prevention program for purposes of section 431:10C-207. The
- 10 director of transportation is also directed to set a cost for
- 11 the programs to enable the programs to be self-sufficient. The
- 12 director of transportation shall adopt rules pursuant to chapter
- 13 91 necessary for the purposes of this [{]section[}]."
- 14 SECTION 2. Section 431:10C-207, Hawaii Revised Statutes,
- 15 is amended to read as follows:
- 16 "§431:10C-207 Discriminatory practices prohibited[+];
- 17 <u>accident prevention program; exception.</u> (a) No insurer shall

1 or indirectly, upon a person's race, creed, ethnic extraction, 2 age, sex, length of driving experience, credit bureau rating, 3 marital status, or physical handicap[-], except as provided in 4 subsection (b). 5 (b) Notwithstanding subsection (a), beginning January 1, 6 2008, all authorized insurers transacting motor vehicle 7 insurance in this State shall implement a rate reduction, as 8 provided in this subsection, of not less than ten per cent from 9 the rates filed with the commissioner for all motor vehicle 10 insurance polices in effect on January 1, 2008, and for each new and renewal policy issued thereafter. The reduced rate shall 11 12 apply to any policyholder who: 13 (1) Is fifty-five years of age or older; and 14 (2) Has satisfactorily completed an accident prevention 15 course or a refresher provided by under the 16 department's accident prevention program pursuant to 17 section 286-108.4. 18 The reduced rate shall be applicable for three years following 19 satisfactory completion of the course, at which time the insured shall be required to retake the course or take a refresher 20 21 course in order to continue to qualify for the reduced rate."

- 2 and stricken. New statutory material is underscored.
- 3 SECTION 4. This Act shall take effect upon its approval.
