JUSTIFICATION SHEET

DEPARTMENT:

BUDGET AND FINANCE

TITLE:

A BILL FOR AN ACT RELATING TO THE HAWAII EMPLOYER-UNION HEALTH BENEFITS TRUST FUND.

PURPOSE:

The purpose of this bill is to clarify the definition of "employee-beneficiary" by deleting obsolete language and by revising language used in the definition to be consistent with Hawaii Employer-Union Health Benefits Trust Fund (EUTF) administrative rules and current practice.

MEANS:

Amend section 87A-1, Hawaii Revised Statutes.

JUSTIFICATION:

The reason for this bill is to eliminate any confusion or misinterpretations regarding which "beneficiaries" of an employee killed in the performance of duty or of a deceased retiree are eligible to become EUTF employee-beneficiaries. The intent of this bill is not to make new persons eligible for EUTF benefits nor to deny EUTF benefits to persons who now are eligible.

Impact on the public: The bill has no direct impact on the public. Based on current EUTF rules and practices, there are no costs or cost savings associated with this bill.

Impact on the department and other agencies:
This bill does not change current EUTF
practice, and therefore it will have no
impact on the department or other agencies
or their employees. By clarifying statutory
language, the bill will assist EUTF to more
conclusively and consistently determine
eligibility for benefits.
