## A BILL FOR AN ACT

<u>S.B. NO. 1433</u>

RELATING TO TEACHING.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to help assure the 2 quality of public education over the long-term by directing more resources to schools not presently making adequate yearly 3 progress to satisfy that requirement. The Act provides 4 incentives to encourage national board certificated teachers to 5 6 apply their nationally recognized skills to helping those public 7 schools that have not made adequate yearly progress meet those 8 requirements.

9 SECTION 2. Subpart C, of part III, of chapter 302A, Hawaii
10 Revised Statutes, is amended by adding a new section to be
11 appropriately designated and to read as follows:

<u>"§302A-</u> Incentives to national board certificated
<u>teachers to assist public schools achieve adequate yearly</u>
progress. (a) Every teacher who maintains a current national
board certification, and teaches and mentors other teachers at a
public school, including a public charter school, that has not
satisfied the State's adequate yearly progress requirement for
at least three years shall be paid a \$10,000 bonus at the end of

To encourage those with national board certifications to teach in public and charter schools that are in need of improvement.

A BILL FOR AN ACT RELATING TO TEACHING

This program would also offer a \$10,000 bonus stipend per year to national board certified teachers who commit to teach in a school, including a charter school, that is planning for restructuring, restructuring, or in corrective action. The nationally board certified teacher would need to commit to teach in that school for three years, and would mentor other teachers in the school as well as instruct. Upon completion of the three-year commitment, the teachers will be provided the opportunity to return to their original schools.

JUSTIFICATION:

Add a new section to chapter 302A, Hawaii

of September 2006, there are 173 (out of 282) public and charter schools that have not met adequate yearly progress (AYP) as defined by the federal No Child Left Behind Act and have been classified by the Hawaii Department of Education as planning for restructuring, restructuring, or in corrective action. This constitutes 61% of our schools statewide.

It would provide incentives, through financial bonuses, for those with national certifications to assist classroom teachers through mentoring arrangements, earning the title of master teacher.

National board certified teachers go through a professional development process based on advanced standards guided by five core propositions that articulate what accomplished teachers should know and be able to do. According to the Hawaii Teacher Standards Board, there are about 123 national board certified teachers teaching in Hawaii's public schools as of December 2006. These teachers are a resource and could help improve overall student and school achievement by mentoring fellow teachers in applying the skills, knowledge, and methods that they have learned through the national board certification process.
