A BILL FOR AN ACT

RELATING TO TEACHING THE HAWAIIAN LANGUAGE IN THE PUBLIC SCHOOLS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that there is a need to
require the department of education to teach the Hawaiian
language in the public schools.

4 The use of the Hawaiian language is embedded in the State Constitution. The preamble to the constitution proclaims: 5 "We. the people of Hawaii, grateful for Divine Guidance, and mindful 6 of our Hawaiian heritage and uniqueness as an island State, 7 8 dedicate our efforts to fulfill the philosophy decreed by the 9 Hawaii State motto, 'Ua mau ke ea o ka aina i ka pono.'" Moreover, article X, section 4 of the state constitution 10 11 requires the State to promote the study of Hawaiian culture, 12 history, and language and provide for a Hawaiian education program consisting of language, culture, and history in the 13 public schools. Furthermore, article XV, section 4 of the state 14 constitution makes English and Hawaiian the official languages 15 16 of the State.
