A BILL FOR AN ACT

RELATING TO PERMANENT ABSENTEE STATUS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that absentee voting
- 2 continues to be convenience desired by many Hawaii voters. The
- 3 legislature also finds that in 2004 and 2006 in the city and
- 4 county of Honolulu, sixty per cent of absentee mail voters were
- 5 repeat absentee mail voters. The legislature also finds that in
- 6 the State of California, roughly fifteen per cent of all
- 7 registered voters opt for permanent absentee voter status.
- 8 The purpose of this Act is to authorize a permanent
- 9 absentee voter list for Hawaii voters.
- 10 SECTION 2. Chapter 15, Hawaii Revised Statutes, is amended
- 11 by adding four new sections to be appropriately designated and
- 12 to read as follows:
- 13 "S15- Application for permanent absentee voter status;
- 14 application in person or by notarized mail request. (a) Any
- 15 registered voter may apply for permanent absentee voter status
- 16 by (presenting oneself to the clerk) and submitting an
- 17 application to the clerk pursuant to this section, or by
- 18 submitting a notarized application if application is by mail.

If a registered voter is granted permanent absentee voter status 1 2 pursuant to this section, the voter shall not be required to submit a separate request for each election, but shall receive 3 an absentee ballot for each election in which the voter is 4 5 eligible to vote. 6 (b) The application for permanent absentee voter status 7 shall include voter information required in section 15-4. The 8 application shall contain an attestation by the applicant that 9 the applicant desires to vote by absentee mail ballot only. 10 (c) A permanent absentee voter shall be responsible for 11 reapplying to update any changes that occur to personal information, including changes to the voter's forwarding 12 13 address. 14 §15- Permanent absentee voters prohibited from voting at the polls. A voter who has been granted permanent absentee 15 16 voter status pursuant to this section shall be permitted to vote at the polling place for any reason. Permanent absentee voters 17 shall be responsible for requesting a replacement ballot prior 18 19 to election day if the requested absentee ballot is spoiled or

not received.

1 returned as spoiled or voluntarily surrendered, shall be 2 considered cast and may not recast for any reason." 3 SECTION 2. The chief election officer shall adopt rules pursuant to chapter 91 to implement permanent absentee voting. 4 5 There is appropriated out of the general SECTION 3. 6 revenues of the State of Hawaii the sum of \$50,000, or so much 7 thereof as may be necessary for fiscal year 2007-2008, and the 8 same sum, or so much thereof as may be necessary for fiscal year 9 2008-2009, to implement permanent absentee voting. 10 The sums appropriated shall be expended by the office of elections for the purposes of this Act. 11 12 SECTION 4. New statutory material is underscored. 13 SECTION 5. This Act shall take effect on January 1, 2008; 14 provided that section 3 shall take effect on July 1, 2007; 15 provided further that the appropriation provided in section 3 is 16 released on or before January 1, 2008. 17
