RELATING TO COUNTIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Chapter 291C, Hawaii Revised Statutes, is 1 amended by adding a new part to be appropriately designated and 2 3 to read as follows: "PART TRANSMITTAL OF TRAFFIC FINES 4 AND FORFEITURES TO COUNTIES 5 6 **S291C-A Definitions.** For purposes of this chapter, unless 7 the context clearly requires otherwise: "Traffic infraction" means the same as defined in section 8 291D-2. 9 10 "Uncontested traffic infraction" means a traffic infraction 11 which the person noticed under section 291D-5 does not contest. 12 A person "does not contest" an infraction if, in accordance with 13 section 291D-6(b)(1), the person admits the commission of the 14 infraction without requesting a hearing to explain mitigating 15 circumstances and pays or remits bail forfeiture by mail within 16 thirty days.

1 June 30, 2008, the state director of finance shall transmit to 2 each county, not more than thirty days after the end of each fiscal quarter, fifty per cent of all the fines and forfeitures 3 collected for uncontested traffic infractions committed in that 4 county that are in excess of amounts required by the State to 5 6 pay the administrative costs of the traffic violations bureau. Subsection (a) shall not apply to: 7 (b) (1) Fines and forfeitures for violations that occur on 8 9 state off-street parking facilities, parks, airports, 10 and harbors that are subject to enforcement by the 11 State; and (2) Fines and forfeitures that are required by law to be 12 paid into a special, revolving, or trust fund. 13 No county shall be entitled to any portion of the fines and 14

15 forfeitures described in this subsection.

1 (b) Subsection (a) shall not apply to: 2 (1)Fines and forfeitures for violations that occur on 3 state off-street parking facilities, parks, airports, 4 and harbors that are subject to enforcement by the State; and 5 6 (2) Fines and forfeitures that are required by law to be 7 paid into a special, revolving, or trust fund. No county shall be entitled to any portion of the fines and 8 forfeitures described in this subsection." 9 10 SECTION 2. Section 291C-171, Hawaii Revised Statutes, is 11 amended by amending subsection (a) to read as follows: "(a) All fines and forfeitures collected upon conviction 12 or upon the forfeiture of bail of any person charged with a 13 14 violation of any section or provision of the state traffic laws and all assessments collected relating to the commission of 15 traffic infractions shall be paid to the director of finance of 16 17 the State. The judiciary shall identify those uncontested 18 traffic infractions as defined in section 291C-A. The disposition of fines and forfeitures paid to the state director 19 of finance shall be subject to sections 291C-B and 291C-C." 20 SECTION 3. In codifying the new sections added by section 21 1 of this Act, the revisor of statutes shall substitute 22 SB LRB 07-1368.doc
