A BILL FOR AN ACT

RELATING TO MILITARY INSTALLATIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. The legislature finds that, in December 2001, 1 the United States Congress authorized a new round of military 2 installation and base realignments and closures to be 3 implemented in 2005. In the past, certain base closings 4 resulted because of the loss of the effectiveness of a military 5 6 installation that was caused by the encroachment on the installation by nearby civilian urban growth. The legislature further finds that all branches of the 8 United States armed services in Hawaii are not only vital 9 contributors to the economy of the State but are also 10 productive, contributing community members. 11 The purpose of this Act is to require sufficient notice to 12 13 commanding officers of military installations in the State of: 14 (1)
- Proposed zoning changes on lands within three thousand feet or two miles (depending on the size of the 15 population of the county) of any military 16
- installation; and 17

14	thousand feet or two miles of any military installation. (a)												
15	Any county planning department or commission that processes a												
16	zoning change application shall notify the authorities of any												
17	military installation:												
18	(1) Within three thousand feet, for counties with a												
19	population of five hundred thousand or more residents;

21	(2) Within two miles, for counties with a population of												
22	fewer than five hundred thousand residents,
