A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR SMALL BUSINESS DEVELOPMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to appropriate
- 2 moneys to the Hawaii Small Business Development Center Network
- 3 to further its mission of providing assistance to small
- 4 businesses through management-force training. Management-force
- 5 training promotes improvements in the conditions under which
- 6 small businesses thrive and promotes sustainable economic
- 7 development. The Hawaii Small Business Development Center
- 8 Network has provided management-force training statewide since
- 9 1990.
- 10 A sustainable economy is most effectively garnered through
- 11 an educated workforce. This includes the short-term education
- 12 of small business owners and managers who create new jobs and
- 13 generate greater tax revenues for the State. These increased
- 14 tax revenues support the social, health, and educational
- 15 programs of the government.
- 16 The Hawaii Small Business Development Center Network
- 17 promotes a healthy and sustainable economy by providing
- 18 consulting and training to existing small businesses and new

- 1 ventures. It is the only accredited business assistance
- 2 organization in Hawaii and the only such organization that
- 3 conducts third-party annual economic impact studies of its
- 4 outcomes. Moreover, it is part of a matching-funds program
- 5 partially funded by the United States Small Business
- 6 Administration, the University of Hawaii at Hilo, and a
- 7 consortium of other federal, state, and private-sector sponsors
- 8 and partners.
- 9 This investment in human capital will lead to real,
- 10 sustained growth and high productivity. Funding this Act would
- 11 generate an annual economic impact of approximately \$29,000.
- 12 This projection is based on an independent economic impact study
- 13 completed in 2004, The Annual Economic Impact of the Hawaii
- 14 Small Business Development Center. According to the study, for
- 15 every dollar invested by the State, \$4.45 was returned to the
- 16 State in the first year in new incremental taxes from job
- 17 creation, retention of existing jobs, and sales increases.
- 18 SECTION 2. There is appropriated out of the general
- 19 revenues of the State of Hawaii the sum of \$712,000 or so much
- 20 thereof as may be necessary for fiscal year 2007-2008, to create
- 21 sustainable economic development through consulting and training

2	as follows:	
3	(1)	\$114,000 to fund an existing, but vacant, position for
4		an associate state director.
5	(2)	\$215,000 to re-establish a consulting and training
6		program in Kailua-Kona that will bring the Hawaii
7		Small Business Development Center Network into
8		compliance with the requirements of the United States
9		Small Business Administration;
10	(3)	\$268,000 to fill a vacant position at the Hawaii
11		Business Research Library and at the Honolulu center
12		and to create an additional position at the Honolulu
13		center; and
14	(4)	\$80,000 to restore funds lost to indirect fees.
15	The	sum appropriated shall be expended by the University of
16	Hawaii-Hilo for the purposes of this Act.
