Section 92F-12, Hawaii Revised Statutes, is 2 amended by amending subsection (a) to read as follows: 3 "(a) Any other provision in this chapter to the contrary 4 notwithstanding, each agency shall make available for public 5 inspection and duplication during regular business hours: 6 (1)Rules of procedure, substantive rules of general 7 applicability, statements of general policy, and 8 interpretations of general applicability adopted by 9 the agency; 10 (2) Final opinions, including concurring and dissenting opinions, as well as orders made in the adjudication 11 12 of cases, except to the extent protected by section 13 92F-13(1);14 (3) Government purchasing information, including all bid 15 results, except to the extent prohibited by section 16 92F-13;
