# A BILL FOR AN ACT

RELATING TO VETERANS LICENSE PLATES.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. Section 249-9.2, Hawaii Revised Statutes, is  
2 amended to read as follows:

3           "§249-9.2 Special number plates; military service. (a)

4 In lieu of the number plates contracted on behalf of the  
5 counties by the director of finance of the city and county of  
6 Honolulu, the director of finance shall provide [~~for a fee~~] one  
7 set of special number plates upon the receipt of an application  
8 together with:

- 9           (1) Specific proof that the applicant was awarded the  
10           Purple Heart by the United States Department of  
11           Defense for wounds received in military or naval  
12           combat against an armed enemy of the United States;  
13           (2) Certification that the applicant is a veteran;  
14           (3) Specific proof that the applicant was serving the  
15           United States in the military or as a civilian, on  
16           Oahu, or offshore at a distance of not more than three  
17           miles at the time of the December 7, 1941, attack on



- 1 Pearl Harbor. Certification from the Hawaii state  
2 chairperson of the Pearl Harbor Survivors Association  
3 shall constitute sufficient proof;
- 4 (4) Specific proof that the applicant was confined as a  
5 prisoner of war while providing military service to  
6 the United States; or
- 7 (5) Certification from the United States Department of  
8 Veterans Affairs or the state office of veterans'  
9 services that the applicant is a combat veteran or a  
10 veteran of the Vietnam conflict, the Korean conflict,  
11 World War II, or the Persian Gulf conflict.
- 12 (b) The design of the plates for:
- 13 (1) Purple heart recipients shall include the words  
14 "COMBAT WOUNDED";
- 15 (2) Veterans shall include the word "VETERAN";
- 16 (3) Pearl Harbor survivors shall include the words "PEARL  
17 HARBOR SURVIVOR";
- 18 (4) Former prisoners of war shall include the words  
19 "FORMER PRISONER OF WAR";
- 20 (5) Combat veterans shall include the words "COMBAT  
21 VETERAN";



1 (6) Veterans of the Vietnam conflict shall include the  
2 words "VIETNAM VETERAN";

3 (7) Veterans of the Korean conflict shall include the  
4 words "KOREA VETERAN";

5 (8) Veterans of World War II shall include the words  
6 "WORLD WAR II VETERAN"; and

7 (9) Veterans of the Persian Gulf conflict shall include  
8 the words "PERSIAN GULF VETERAN".

9 These designations shall be imprinted on the left side of  
10 the license plates in a manner similar to congressional and  
11 honorary consul license plates.

12 (c) No fee shall be charged to an applicant for a special  
13 number license plate under this section.

14 [~~e~~] (d) Registration certificates and license plates  
15 issued under this section shall not be transferable to any other  
16 person. Special number plates for military service shall be  
17 assigned to a noncommercial passenger motor vehicle, a  
18 noncommercial motorcycle, or motor scooter registered in the  
19 name of the qualified applicant and shall be available in any  
20 category of special number plates for military service. Prior  
21 to the transfer of the ownership of the qualified person's  
22 vehicle to another party, the special number plates shall be



1 surrendered to the director of finance as a condition to the  
2 issuance of replacement special number plates; provided that the  
3 director of finance shall allow the survivor of the qualified  
4 person, upon request, to retain the front special number plate  
5 as a memorial.

6 [~~(d)~~] (e) The director of finance shall authorize the  
7 design of a license plate that is readily identifiable and  
8 distinguishable under actual traffic conditions and shall adopt  
9 rules pursuant to chapter 91 to carry out this section."

10 SECTION 2. Statutory material to be repealed is bracketed  
11 and stricken. New statutory material is underscored.

12 SECTION 3. This Act shall take effect on July 1, 2007.
