A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR STATE LIFEGUARDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Lifeguards serve an essential function in a

 State surrounded by ocean and featuring numerous freshwater

 attractions. Lifeguards rescue people who get into trouble in

 the sometimes unpredictable surf, administer first aid to those
- + the sometimes displedictable suil, administer first and to those
- 5 who are injured, and teach the public how to be safe in the
- 6 water. Lifeguards allow the public to enjoy the natural beauty
- 7 of our waters, thus contributing to Hawaii's reputation as a
- 8 desirable place to live or visit. The legislature finds,
- 9 however, that the islands of Kauai and Maui do not have state-
- 10 funded lifeguards at state beach parks.
- 11 The purpose of this Act is to appropriate moneys to pay for
- 12 lifeguards for the islands of Kauai and Maui in areas under the
- 13 jurisdiction of the department of land and natural resources,
- 14 subject to the provision of county matching funds.
- 15 SECTION 2. There is appropriated out of the general
- 16 revenues of the State of Hawaii the sum of \$, or so
