A BILL FOR AN ACT

RELATING TO MOTOR VEHICLES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 291-14, Hawaii Revised Statutes, is 1 amended to read as follows: 2 "\$291-14 Pickup trucks; passenger restrictions. (a) [No 3 person shall stand in the bed or load-carrying area of any motor 4 vehicle commonly known as a pickup truck while the vehicle is in 5 operation. No operator of any pickup truck shall operate the 6 vehicle with a passenger seated in the bed or load-carrying area 7 of the vehicle unless: 8 (1) There is no scating available in the cab of the vehicle. 10 (2) The side racks of the vehicle are securely attached 11 12 and the tailboard or tailgate is securely closed; 13 (3) Every passenger in the bed or load-carrying area of the vehicle is seated on the floor and does not 14 attempt to control unlashed cargo. No operator of 15 16 any pickup truck may operate the vehicle with any passenger in the bed or load-carrying area of the 17

- 6 bed, and has a maximum gross vehicle weight rating (GVWR) of
