## A BILL FOR AN ACT

RELATING TO SPECIAL PURPOSE REVENUE BONDS FOR NOT-FOR-PROFIT CORPORATIONS THAT PROVIDE HEALTH CARE FACILITIES TO THE GENERAL PUBLIC.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the issuance of
- 2 special purpose revenue bonds under this Act is in the public
- 3 interest and for the public health, safety and general welfare.
- 4 The purpose of this Act is to extend the sunset date for
- 5 the issuance of special purpose revenue bonds for The Queen's
- 6 Health Systems, a not-for-profit corporation, to assist with
- 7 financing costs of construction, improvements, and equipment of
- 8 health care facilities
- 9 SECTION 2. Act 176, Session Laws of Hawaii 2003, is
- 10 amended by amending sections 4 and 5 to read as follows:
- "SECTION 4. The department of budget and finance is
- 12 authorized, from time to time, including time subsequent to
- 13 June 30, [2008,] 2013, to issue special purpose revenue bonds in
- 14 whatever principal amounts the department of budget and finance
- 15 shall determine to be necessary to refund the special purpose
- 16 revenue bonds authorized in section 2 and any refunding of



- 1 special purpose revenue bonds authorized in this section,
- 2 regardless of whether the outstanding special purpose revenue
- 3 bonds or refunding special purpose revenue bonds have matured or
- 4 are the subject of redemption or whether the refunding special
- 5 purpose revenue bonds shall be bonds for the multi-project
- 6 programs described in section 2. In making this determination,
- 7 the department of budget and finance shall comply with federal
- 8 law relating to the exemption from federal income taxation of
- 9 the interest on bonds of the nature authorized by this section.
- 10 SECTION 3. The authorization to issue special purpose
- 11 revenue bonds under this Act shall lapse on June 30, [2008.]
- **12** 2013."
- 13 SECTION 4. Statutory material to be repealed is bracketed
- 14 and stricken. New statutory material is underscored.
- 15 SECTION 5. This Act shall take effect on June 29, 2008.
