A BILL FOR AN ACT

RELATING TO THE ISSUANCE OF SPECIAL PURPOSE REVENUE BONDS FOR KANU O KA AINA.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds and declares that the SECTION 1. 2 issuance of special purpose revenue bonds under this Act is in the public interest and for the public's general welfare. 3 4 SECTION 2. Pursuant to part VII and VIII, chapter 39A, 5 Hawaii Revised Statutes, the department of budget and finance, 6 with the approval of the governor, is authorized to issue 7 special purpose revenue bonds in the total amount not to exceed 8 \$30,000,000, in one or more series, for the purpose of assisting 9 Kanu O Ka Aina, a Hawaii not-for-profit corporation, to finance 10 the construction of its educational community development 11 facilities in the State of Hawaii. The legislature finds that the construction of facilities of Kanu O Ka Aina constitutes a 12 13 project for purposes of part VII and VIII, chapter 39A, Hawaii 14 Revised Statutes, and the financing thereof is assistance to a 15 not-for-profit community development project that serves the general public by providing early childhood education and care **16 17** facilities, elementary schools, secondary schools, colleges and

universities.
