A BILL FOR AN ACT

RELATING TO GAMBLING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that there is a proliferation of vending machines that dispense "sweepstakes" 2 3 game cards that can also be used to make brief long distance 4 telephone calls. These cards typically cost \$1 each and, while 5 vendors make it possible to obtain a card by mail at no cost, 6 these cards are from a separate pool of possible winners than 7 the pool of cards placed in a vending machine. 8 The legislature further finds that purchasers may buy one 9 hundred or more of these cards in an effort to win a cash prize 10 and often dispose of losing cards instead of using them for one-11 or two-minute long distance calls each card authorizes. With 12 the wide availability of low cost and flat rate long distance 13 calling plans on land line telephone accounts and free long 14 distance calling plans on cellular telephone accounts, the \$1 15 cost of these "sweepstakes" cards far exceeds the value of the 16 long distance call authorized by the cards and the ability to 17 make a long distance call with the card is clearly incidental to


its value as a "sweepstakes" entry. These "sweepstakes" cards

- 1 are not like the chances to win prizes offered by, for example,
- 2 fast food restaurants, because those chances are offered in
- 3 connection with, and merely incidental to, the sale of a bona
- 4 fide product, namely, a meal.
- 5 The purpose of this Act is to clarify that, where the
- 6 chance to win something of value is offered in conjunction with
- 7 the purchase of an item, that activity constitutes gambling,
- 8 even if a chance to win is offered by mail at no cost, if the
- 9 item is offered at a price that is disproportionately high
- 10 compared to the value of the item, or if the chance to win at no
- 11 cost by mail is offered from a pool different from the pool from
- 12 which the chance to win via purchase is drawn.
- 13 SECTION 2. Chapter 712, Hawaii Revised Statutes, is
- 14 amended by adding a new section to part III, to be appropriately
- 15 designated and to read as follows:
- 16 "§712-Free play not a defense; when. It shall not be
- 17 a defense to an offense charged under this part that free play
- 18 was offered, if the free play was offered by mail as an
- 19 alternative to play via purchase of:
- 20 (1) An item that is not bona fide or is offered at a price
- 21 that is disproportionately high compared to the value
- 22 of the item purchased; or

(2) A chance to win if the free play by mail is offered 1 2 from a pool different from the pool from which the 3 chance to win via purchase is drawn. 4 This section applies only to devices into which a consumer 5 inserts money and the device provides a sweepstakes ticket or 6 card that, by reason of chance, may entitle the consumer to a 7 money prize." SECTION 3. Section 712-1220, Hawaii Revised Statutes, is 8 9 amended to read as follows: 10 "§712-1220 Definitions of terms in this part. In this 11 part unless a different meaning plainly is required, the 12 following definitions apply[-]: 13 [-(1)-]"Advance gambling activity". A person "advances 14 gambling activity" if [he] the person engages in conduct that 15 materially aids any form of gambling activity. Conduct of this 16 nature includes but is not limited to conduct directed toward 17 the creation or establishment of the particular game, contest, 18 scheme, device, or activity involved, toward the acquisition or 19 maintenance of premises, paraphernalia, equipment, or apparatus 20 therefor, toward the solicitation or inducement of persons to 21 participate therein, toward the actual conduct of the playing 22 phases thereof, toward the arrangement of any of its financial HB1836 SD2 JDL.doc

1	or recording phases, or toward any other phase of its operation		
2	A person advances gambling activity if, having substantial		
3	proprietary control or other authoritative control over premise		
4	being used with [his] the person's knowledge for purposes of		
5	gambling activity, [he] the person permits that activity to		
6	occur or continue or makes no effort to prevent its occurrence		
7	or continuation. A person advances gambling activity if [he]		
8	the person plays or participates in any form of gambling		
9	activity. With regard to devices into which a consumer inserts		
10	money and the device provides a sweepstakes ticket or card that		
11	by reason of chance, may entitle the consumer to a money prize,		
12	conduct that constitutes gambling activity under this definition		
13	is not rendered otherwise by the fact that free play is offered		
14	by mail as an alternative to play via purchase of:		
15	(1)	An item that is not bona fide or is offered at a price	
16		that is disproportionately high to the value of the	
17		item purchased; or	
18	(2)	A chance to win if the free play by mail is offered

                 "Gambling". A person engages in gambling if [he]

    of a contest of chance or a future contingent event not under

    something of value in the event of a certain outcome. Gambling

    does not include bona fide business transactions valid under the

15		something of value.	
16	[(7)] "Mutuel" means a form of lottery in which the	
17	winning chances or plays are not determined upon the basis of a		
18	drawing or other act on the part of persons conducting or		
19	connected with the scheme, but upon the basis of the outcome or		
20	outcomes of a future contingent event or events otherwise		
21	unrelated to the particular scheme.		

- 1 [(8)] "Player" means a person who engages in gambling
- 2 solely as a contestant or bettor.
- 3 [(9)] "Profit from gambling activity". A person "profits
- 4 from gambling activity" if [he] the person accepts or receives
- 5 money or other property pursuant to an agreement or
- 6 understanding with any person whereby [he] the person
- 7 participates or is to participate in the proceeds of gambling
- 8 activity.
- 9 [(10)] "Social gambling" is defined in section 712-1231.
- 10 [\(\frac{(11)}{1}\)] "Something of value" means any money or property,
- 11 any token, object, or article exchangeable for money or
- 12 property, or any form of credit or promise directly or
- 13 indirectly contemplating transfer of money or property or of any
- 14 interest therein, or involving extension of a service or
- 15 entertainment."
- 16 SECTION 4. This Act does not affect rights and duties that
- 17 matured, penalties that were incurred, and proceedings that were
- 18 begun, before its effective date.
- 19 SECTION 5. Statutory material to be repealed is bracketed
- 20 and stricken. New statutory material is underscored.
- 21 SECTION 6. This Act shall take effect on July 1, 3011.
