A BILL FOR AN ACT

RELATING TO WAGE AND HOUR LAW.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The purpose of this Act is to raise the monthly			
2	salary ceiling under which the wage and hour laws shall apply.			
3	By raising the ceiling, this Act will discourage employers from			
4	creating an atmosphere where overtime is expected but			
5	uncompensated. It is the intent of the legislature that this			
6	Act will apply in instances where this Act provides a higher			
7	wage ceiling than does the federal Fair Labor Standards of 1938,			
8	as amended.			
9	SECTION 2. Section 387-1, Hawaii Revised Statutes, is			
10	amended by amending the definition of "employee" to read as			
11	follows:			
12	""Employee" includes any individual employed by an			
13	employer, but shall not include any individual employed:			
14	(1) At a guaranteed compensation totaling [\$2,000] <u>\$2,800</u>			
15	or more a month, whether paid weekly, biweekly, or			
16	monthly;			
17	(2) In agriculture for any workweek in which the employer

8		Revenue Code;
9	(4)	By the individual's brother, sister, brother-in-law,
10		sister-in-law, son, daughter, spouse, parent, or

12	(5)	In a bona fide executive, administrative, supervisory,
13		or professional capacity or in the capacity of outside
14		salesperson or as an outside collector;
15	(6)	In the propagating, catching, taking, harvesting,
16		cultivating, or farming of any kind of fish,
17		shellfish, crustacean, sponge, seaweed, or other
18		aquatic forms of animal or vegetable life, including
19		the going to and returning from work and the loading
20		and unloading of such products prior to first
21		processing;


