A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Chapter 304A, Hawaii Revised Statutes, is 1 2 amended by adding a new section to be appropriately designated 3 and to read as follows: 4 "§304A- General fund formulation. Beginning in fiscal 5 year 2008-2009, and every year thereafter, the general fund 6 budget appropriations for the University of Hawaii shall be 7 based upon the amount of funding required per student. 8 Specifically, funding shall be based upon a student weighted 9 formula that factors into account the number of enrolled 10 students, their classification as graduate or undergraduate, 11 their enrollment in a program that leads to a degree, and the 12 accumulated credit hours for each student under that 13 classification and program. Funding per student shall be 14 reduced after a specified number of credit hours have been 15 accumulated, depending on the student's graduate or 16 undergraduate classification and the student's enrollment in a 17 degree program or otherwise.

8	funding model established under this Act and to upgrade their
9	computer systems technology to implement the funding model.

11	University of Hawaii for the purposes of this Act.

13	and stricken. New statutory material is underscored.
