RELATING TO THE HAWAII HEALTH SYSTEMS CORPORATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Section 323F-3, Hawaii Revised Statutes, is
2	amended b	y amending subsection (b) to read as follows:
3	"(b)	[Ten members of the corporation board shall be
4	appointed	by the governor as follows:
5	(1)	One member from region I who resides in the city and

7	(2)	One member from region II who resides in the county of
8		Kauai;
9	(3)	One member from region III who resides in the county

11	(4)	One member from region IV who resides in the eastern
12		section of the county of Hawaii;
13	(5)	One member from region V who resides in the western
14		section of the county of Hawaii;
15	(6)	One member from region II who resides in the county of
16		Kauai or from region III who resides in the district
17		of Hana or on the island of Lanai; provided that in no

1	event-shall the member be appointed from the same
2	region for two consecutive terms; and
3	(7) Four at-large members who reside in the State.]
4	Five members of the board shall be appointed by the governor as
5	provided in section 26-34 from a list of three candidates
6	nominated for each position by the president of the senate, and
7	five members shall be appointed by the governor as provided in
8	section 26-34 from a list of three candidates nominated for each
9	position by the speaker of the house of representatives;
10	provided that the members of the board shall include at least
11	one member from each of the five regions of the corporation.
12	The eleventh member shall be the chairperson of the
13	executive public health facility management advisory committee,
14	who shall serve as an ex officio, voting member.
15	The twelfth member, who shall serve as a voting member,

2	at any of the corporation's public health facilities and shall
3	be elected to the corporation board [by a simple majority vote
4	of the members of the executive public health facility
5	management advisory committee from a list of qualified nominees
6	submitted by the public health facility management advisory
7	committee for the region from which the physician member is to
8	be chosen.] by a majority vote of the physicians with active
9	medical staff privileges at one of the corporation's public


1 the formulation of regional operational and capital improvement 2 budgets, and the planning, construction, improvement, 3 maintenance, and operation of public health facilities within 4 its respective jurisdiction [and shall sit in an advisory 5 capacity to the governor on matters concerning the nominees for 6 positions on the corporation board]. Nothing in this section 7 shall be construed as precluding or preventing the committees from coordinating their efforts and activities with the facility 8 9 administrators within their counties." 10 SECTION 3. Statutory material to be repealed is bracketed 11 and stricken. New statutory material is underscored.

Hawaii Health Systems Corporation; Board Membership

Description:

Alters Hawaii health systems corporation board membership by having governor appoint 10 members, 5 each from nominees by house speaker and senate president (3 nominees per position). Increases physician member term from 2 to 4 years; alters manner of appointment. Eliminates regional committees' advisory capacity to the governor concerning nominees for the board.
