## NOTICE TO ALL FOOD STAMP RECIPIENTS IMPORTANT — PLEASE READ

Effective October 1, 2008, State and Federal laws provide for the following:

Maximum Food Stamp Allotments: These are benefit amounts your household would receive if your household had no income. Household Each Additional

- Additionally, the maximum excess shelter deduction is raised from \$431.00 to \$446.00.
- The homeless shelter allowance of \$143.00 will remain unchanged.
- However, the standard deduction has changed as follows:

## Standard Deduction for FFY 2009:

1 to 3 persons	\$144.00
4 persons	\$147.00
5 persons	\$172.00
6 or more persons	\$197.00

As a reminder, the Standard Utility Allowance (SUA) has been raised from \$274.00 to \$287.00 for FFY 2009, effective October 1, 2008.

The Limited Utility Allowance (LUA) has been raised from \$79.00 to \$83.00 for FFY 2009, also effective October 1, 2008.

If the SUA/LUA is used as part of your shelter deduction and if you have had no changes in your food stamp case, your food stamps benefits may be changed. With the changes in your food stamp benefits, the amount you will get depends on other household changes. These changes will be included in any notice you get that tells you about other changes in your food stamp benefits.

If you think we made a mistake in figuring your October food stamps due to the new amounts for allotments and SUA/LUA you may ask for a state hearing, within 90 days of when you got this letter by writing to:

You can speak for yourself at the hearing or you can have a friend, attorney, or other person speak for you, but you must get these people to help you. You may ask for free legal aid at a legal aid office in your area.

此外,在 2008年十月一日開始,有限制的水電費寬減額 (LUA) 金額也由 \$79 提高到 \$83。

如果SUA/LUA是用作為你的部份住宿扣除額,而你的糧食券案件沒有任何改變的話,你的糧食券福利可能會被改變。隨著你糧食券福利的改變,你將領取的金額取決於你家庭的情況。這些改變將包括在你所收到有關你糧食券福利其他改變的通知中。
