Sir and Madam:

Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 3352, H.D. 2, S.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO AN AUDIT OF THE HAWAII DISABILITY RIGHTS CENTER,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this bill is to ensure effective and reasonable advocacy services to persons with developmental disabilities or mental illness by:

- (1) Establishing the Auditor's power to examine and inspect records and documents of the Hawaii Disability Rights Center (HDRC);
- (2) Requiring the Auditor to perform a financial and management audit every seven years of the entity or agency designated by state law to ensure the protection of

persons with developmental disabilities or mental illness, to ensure that state funds are being spent in accordance with applicable laws; and

(3) Conducting a financial and management audit of HDRC.

Your Committee on Conference requests that the Auditor review all financial, management, and program audits performed on HDRC for the past five years by any federal agency or private entity.

Your Committee on Conference has amended this bill by:

- Removing provisions that change the Auditor's scope of (1)duties to include examinations of advocacy services, including advocacy services to persons with developmental disabilities or mental illness;
- (2)Removing the appropriation;
- Specifying that the Auditor conduct an audit of HDRC; (3)
- (4)Changing the effective date to upon approval; and
- (5) Making technical, nonsubstantive amendments for clarity, consistency, and style.
