"A BILL FOR AN ACT RELATING TO PUBLIC SAFETY,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this bill is to create a strategic plan to provide adequate services to female prisoners who are residents of Hawaii and are returning to Hawaii after being incarcerated on the mainland.

Your Committee on Conference amended this bill by:

(1) Inserting the amount of \$100,000 to be appropriated out of the General Fund for the Department of Public Safety to develop a strategic plan to ensure successful reentry into the community of as many female prisoners as possible who
