Your Committee on Conference on the disagreeing vote of the Senate to the amendments proposed by the House of Representatives in S.B. No. 2849, S.D. 1, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO AGRICULTURAL LANDS,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to allow the use of agricultural lands:

- For agricultural-energy facilities, provided that the primary activity of the agricultural-energy enterprise is agricultural activity; and
- (2) To provide affordable rental housing to agricultural workers and agricultural support buildings to agricultural business operators and support services by using or rehabilitating existing structures on plantation community subdivisions.
