BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1	. Chapter 587, Hawaii Revised Statutes, is
2	amended b	y add	ing a new section to be appropriately designated
3	and to re	ad as	follows:
4	" <u>§587-</u>		Foster children; guiding principles. (a) The
5	departmen	t, as	foster or permanent custodian, shall abide by the
6	following	guid	ing principles and shall ensure that foster
7	children:		
8	(1)	Live	in a safe and healthy home, free from physical,
9		psycl	nological, sexual, and other abuse;
10	(2)	Have	adequate:
11		<u>(A)</u>	Food that is nutritious and healthy;
12		<u>(B)</u>	Clothing;
13		<u>(C)</u>	Medical, dental and orthodontic, and corrective
14			vision care; and
15		<u>(D)</u>	Mental health services;
16	<u>(3)</u>	<u>Have</u>	supervised in-person contact and telephone or
17		mail	correspondence with the child's parents and

1		siblings while the child is in foster care unless
2		prohibited by court order;
3	(4)	Have direct contact with a social worker, guardian ad
4		litem, and probation officer;
5	<u>(5)</u>	May freely exercise their own religious beliefs,
6		including refusal to attend any religious activities
7		and services;
8	<u>(6)</u>	Have a personal bank account and assistance managing
9		their personal income, consistent with the child's age
10		and development, unless prohibited due to safety or
11		health concerns;
12	<u>(7)</u>	Have the right to attend school and participate in
13		appropriate extracurricular activities, and, if a
14		child is moved during a school year, complete the
15		school year at the same school, if practicable; and
16	(8)	Are provided with life skills training and a
17		transition plan starting at age twelve to provide
18		adequate transitioning for children aging out of the
19		foster care system. The department shall provide
20		written information to all foster children twelve
21		years of age or older and their foster parents about
22		available independent living programs, including

1	available foster youth organizations, transitional
2	planning services, and independent living case
3	management programs.
4	(b) The family court may issue any necessary orders, sua
5	sponte or upon appropriate motion, to the department of
6	education, department of human services, or department of health
7	to ensure adherence to the guiding principles enumerated in
8	subsection (a)."
9	SECTION 2. New statutory material is underscored.
10	SECTION 3. This Act shall take effect upon its approval.
