The U.S.-Peru Trade Promotion Agreement Provides Enhanced Market Access

The U.S.-Peru Trade Promotion Agreement (TPA) offers tremendous opportunities for Pennsylvania's exporters. When the Agreement enters into force, fully 80 percent of U.S. consumer and industrial exports to Peru, including nearly all information technology products; mining, agriculture, and construction equipment; medical and scientific equipment; auto parts; paper products; and chemicals, will be duty-free immediately. The remaining tariffs phase out over 10 years. U.S. farmers and ranchers will also become much more competitive, benefiting from immediate duty-free treatment of 90 percent of U.S. current exports. Key U.S. agriculture exports such as cotton, wheat, soybeans, high quality beef, apples, pears, peaches, cherries, and almonds will be duty-free upon entry into force of the Agreement. Peru will phase out all other agricultural tariffs within 17 years.

Pennsylvania Depends on World Markets

Pennsylvania's export shipments of merchandise in 2006 totaled \$26.3 billion. Pennsylvania posted the tenth largest export total among the 50 states that year. Pennsylvania's \$10.6 billion increase in exports from 2002 to 2006 was the 7th largest among the 50 states.

Exports Support Jobs for Pennsylvania's Workers – In 2003, export-supported jobs linked to manufacturing accounted for an estimated 3.8 percent of Pennsylvania's total private-sector employment; nearly one-sixth (15.4 percent) of all manufacturing workers in Pennsylvania depended on exports for their jobs. (2003 are the latest data available.)

Exports Sustain Thousands of Pennsylvania's Businesses – A total of 11,184 companies exported goods from Pennsylvania locations in 2005. Of those, 9,831 (88 percent) were small and medium-sized enterprises (SMEs), with fewer than 500 employees.

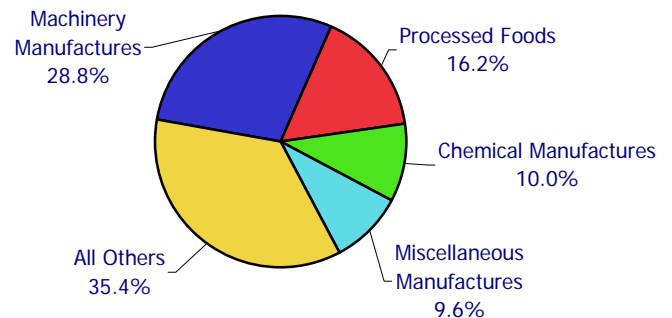
Pennsylvania's SMEs Will Benefit from U.S.-TPA Provisions

SMEs generated one-third (33 percent) of Pennsylvania's total exports of merchandise in 2005. SMEs enterprises particularly benefit from the tariff-eliminating provisions of free trade agreements (FTAs) and should benefit from the significant tariff cuts under the U.S.-Peru TPA. The transparency obligations, particularly those contained in the customs chapter, are also very important to SMEs, which may not have the resources to navigate customs and regulatory red tape.

The U.S.-Peru TPA Moves the Trade Relationship from One-Way Preferences to Reciprocity

In 2006, 98 percent of Peru's exports to the United States entered duty free under unilateral U.S. trade preference programs such as the Andean Trade Preference Act and the Generalized System of Preferences or under zero Normal Trade Relations tariffs. Because of high tariffs, U.S. exporters do not have equivalent access to the Peruvian market. The U.S.-Peru TPA levels the playing field and enhances competition because it moves the U.S.-Peru commercial relationship beyond one-way preferences to full partnership and reciprocal commitments.

The U.S.-Peru TPA Opens New Markets for Pennsylvania's Exports

Chemical Manufactures – Chemical manufactures were Pennsylvania's leading manufactured export category in 2006, accounting for \$4.7 billion in merchandise exports. Chemical manufactures were also Pennsylvania's fastest growing manufactured export in dollar terms from 2002 to 2006, growing by \$2.1 billion during that period. Pennsylvania's exporters of chemical and related products, including pharmaceuticals, cosmetics, fertilizer and agro-chemicals, plastics, and rubber, will benefit from the U.S.-Peru TPA's tariff reductions. Seventy-six percent of U.S. chemical exports will receive duty-free treatment immediately upon entry into force of the agreement, with the remaining tariffs phased out within 10 years. Tariffs on high-value chemical products, including many resins, fertilizers, and soda ash, will be phased out immediately. Current Peruvian chemical tariffs average 7 percent and can be as high as 12 percent.

Machinery Manufactures – Machinery manufactures were Pennsylvania's second leading manufactured export category in 2006 and one in which the state has experienced significant export growth. Pennsylvania exported \$3.4 billion in machinery manufactures in 2006, an increase of \$1.3 billion from 2002. Pennsylvania's exports of machinery will benefit from U.S.-Peru TPA tariff reductions. Eighty-nine percent of U.S. capital goods exports will be immediately duty-free upon entry into force of the agreement. All U.S. exports of agricultural equipment and 95 percent of construction equipment, including bulldozers, mechanical shovels, boring and sinking machinery, and dumpers, will receive duty-free treatment immediately upon entry into force of the agreement; remaining tariffs will be phased out within 10 years. The elimination of Peruvian tariffs on such high-value equipment will provide a competitive boost to Pennsylvania's exporters, who will no longer be facing tariffs that are as high as 12 percent. This will help Pennsylvania's companies take advantage of Peru's growing demand for industrial machinery.

Primary Metal Manufactures – Another of the state's leading manufactured export categories is primary metal manufactures, which accounted for \$3.4 billion of Pennsylvania's total merchandise exports in 2006. Primary metal manufactures were also one of Pennsylvania's fastest growing manufactured export growth categories, up 157 percent from 2002 to 2006.

Pennsylvania's exporters of metals and ores to Peru will be more competitive as tariffs averaging almost 9 percent fall to zero on 81 percent of U.S. exports immediately upon entry into force of the Agreement. Remaining tariffs are phased out within 10 years. Major infrastructure projects and private sector-led development should continue to provide opportunities for U.S. exporters in this sector.

The U.S.-Peru TPA Creates Opportunities for Pennsylvania's Agriculture

In 2006, agricultural exports to the world were estimated at \$1.4 billion. Despite high tariffs and other barriers on most agricultural products, including key Pennsylvania farm products such as dairy, poultry, and beef, U.S. exporters shipped more than \$209 million in U.S. farm products to Peru in 2006. In the free trade agreement, a primary U.S. objective was to change the "one-way street" of duty-free access currently enjoyed by most Peru exports into a "two-way street" that provides U.S. suppliers with access to these markets and levels the playing field with competitors. This objective was achieved.

Free Trade Works for Pennsylvania's Exporters

Since the North American Free Trade Agreement's (NAFTA) entry into force in 1994, Pennsylvania's exports to Canada and Mexico have grown by 156 percent. Pennsylvania's exports to Chile have grown by 63 percent since the entry into force of the U.S.-Chile FTA in 2004. Subsequent to the entry into force of both the U.S.-Jordan FTA in 2001 and U.S.-Singapore FTA in 2004, Pennsylvania's exports to those countries have risen by 175 and 29 percent respectively.

All state export data in this report are based on the Origin of Movement (OM) series. This series allocates exports to state based on transportation origin, i.e., the state from which goods began their journey to the port (or other point) of exit from the United States. The transportation origin of exports is not always the same as the location where the goods were produced. Thus conclusions about "export production" in a state should not be made solely on the basis of the OM state export figures.
