CM/ECF System Unavailability & Release 3.0 Changes

The CM/ECF System will be unavailable from 9:00 a.m. Saturday, May 13, 2006 through 9:00 p.m. Sunday, May 14, 2006 to perform system maintenance and upgrade the CM/ECF software to Release 3.0.

A detailed summary of the changes for attorney and other external filers is available on the Court's website at: http://www.moeb.uscourts.gov/cmecf/docs/admin_proc5_2006.pdf. This summary should be shared with those who assist e-filers in their office. The most significant changes the external filer will see in Release 3.0 are:

CM/ECF Passwords * Release 3.0 does not recognize CM/ECF passwords which include a tilde (~). Attempting to use a password containing a tilde will result in a message of "invalid login." The summary provides instructions how to modify the password (see above link).

Claims

- * **Claim Numbers** will now include extensions, to better reference amended claims. For example, the first claim filed in a case will appear as Claim 1-1. The second claim will be Claim 2-1, etc. When claim 1 is amended, the amended claim will appear as Claim 1-2.
- * A **Claims History** section will be added to the claims register to show any events related to the claim and the history of claim amendments.
- * The **Claims Register** will be available through the **Query** Button.
- * **Transfer of Claims** is improved to automatically update the transferee as the claimant.

Adding Creditors


- * A **Common Creditor** feature is added to allow certain common creditors to be easily added to a case;
- * **Creditor Maintenance** will allow filers to insert up to 10 creditors at one time by typing the creditor information or by copying and pasting it from another document.

Reports

- * Filers will have access to a **Docket Activity Report** and a new **Written Opinions Report**.

- Docketing Screens** * Enhanced case information will display on docketing screens. The docket text for certain events has been updated, and ***Multi-part Motions*** are described in docket text in the order selected by the filer.
- Opening Cases** * ***Case Upload*** has become a national program. The debtor's party ***Role Type*** will be predefined, so the filer no longer has to select the role type when filing a new case.
- Compatibility** * Release 3 works with **Netscape 7.2 and Internet Explorer 6.**
