TREASURY TO AUCTION \$15,000 MILLION OF 2-YEAR NOTES

The Treasury will auction \$15,000 million of 2-year notes to refund \$31,820 million of publicly held securities maturing September 30, 1998, and to pay down about \$16,820 million.

In addition to the public holdings, Federal Reserve Banks hold \$2,242 million of the maturing securities for their own accounts, which may be refunded by issuing an additional amount of the new security.

The maturing securities held by the public include \$3,669 million held by Federal Reserve Banks as agents for foreign and international monetary authorities. Amounts bid for these accounts by Federal Reserve Banks will be added to the offering.

The auction will be conducted in the single-price auction format. All competitive and noncompetitive awards will be at the highest yield of accepted competitive tenders.

The 2-year notes being offered today are eligible for the STRIPS program.

Tenders will be received at Federal Reserve Banks and Branches and at the Bureau of the Public Debt, Washington, D. C. This offering of Treasury securities is governed by the terms and conditions set forth in the Uniform Offering Circular (31 CFR Part 356, as amended) for the sale and issue by the Treasury to the public of marketable Treasury bills, notes, and bonds.

Submission of Bids:

Noncompetitive bids: Accepted in full up to \$5,000,000 at the highest
accepted yield.

Competitive bids:

- (1) Must be expressed as a yield with three decimals, e.g., 7.123%.
- (2) Net long position for each bidder must be reported when the sum
of the total bid amount, at all yields, and the net long position
is \$2 billion or greater.
- (3) Net long position must be determined as of one half-hour prior to
the closing time for receipt of competitive tenders.

Receipt of Tenders:
