^{1.} **Schedules, Statements, Declarations & Means Test Form** - These documents should be assembled and filed in the order listed in the Court's "Filing Requirements - Chapter 7" document provided on the Court's website. All the documents required for a complete petition package may be filed or uploaded in CM/ECF with the voluntary petition as one PDF document except for the B21 Social Security Verification form, which must be filed separately using the B21 Form, Attorney Batch Filings event.

^{2.} **Payment Advices -** Paragraph 6(a) of the Court's Implementation Order requires debtors to provide to the trustee, 14 days before the first setting of the § 341 meeting, either: (1) payment advices or (2) a verified statement that the debtor did not receive payments to which § 521(a)(1)(B)(iv) applies. A sample form for such <u>verified statement</u> is available on the Court's website and through the Office of the United States Trustee. This statement may also be used if tax returns are not available. <u>Current pay amounts should be circled or highlighted on the payment advice submitted to the Trustee.</u> When possible, payment advice and other documents should be provided to the trustee 7 days prior to the meeting along with the required tax returns.

- 3. **Bank Statements -** If the bank statement that is available 14 days prior to the § 341 meeting doesn't cover the date of filing, debtors should contact the bank and bring the appropriate bank statement to the § 341 meeting.
- 4. **Divorce/Separation of Debtors -** If the debtor has been divorced (or legally separated by decree) within two years prior to the filing of the bankruptcy case, all trustees want to see the divorce decree or separation agreement, whichever shows what property is divided between the spouses. Bring the documents to the § 341 meeting unless required to provide them to the trustee in advance.
