**UNANIMOUS CONSENT AGREEMENTS**

## CONFERENCE REPORT TO ACCOMPANY H.R. 4297

1.—*Ordered*, That on Thursday, May 11, 2006, immediately following the time for the two Leaders, the Senate proceed to the consideration of the conference report to accompany H.R. 4297, an act to provide for reconciliation pursuant to section 201(b) of the concurrent resolution on the budget for fiscal year 2006; provided that 8 hours remain out of the statutory time limit and that the time be equally divided. (*May 10, 2006.*)

## S. 1955 (ORDER NO. 417)

2.—*Ordered*, That on Thursday, May 11, 2006, following the vote on the adoption of the conference report to accompany H.R. 4297, the Senate resume consideration of S. 1955, a bill to amend Title I of the Employee Retirement Security Act of 1974 and the Public Health Service Act to expand health care access and reduce costs through the creation of small business health plans and through modernization of the health insurance marketplace; provided that notwithstanding Rule XXII, there be 60 minutes for debate equally divided between the Senator from Wyoming (Mr. Enzi) and the Senator from Massachusetts (Mr. Kennedy) or their designees prior to a vote on the motion to invoke cloture on the modified substitute to the bill, without intervening action or debate.

*Ordered further*, That relative to the cloture motion filed on the modified substitute to S. 1955, the mandatory quorum required under Rule XXII be waived. (*May 10, 2006.*)

## H.R. 22

3.—*Ordered*, That with respect to H.R. 22, an act to reform the postal laws of the United States, provided it shall not be in order for the Senate to consider any conference report or any House amendments to H.R. 22, if it would cause a net increase in on or off budget direct spending in excess of \$5 billion in any of the four 10-year periods beginning in 2016–2055, as estimated by the Congressional Budget Office. (*Feb. 9, 2006.*)

## S. 295

4.—*Ordered*, That the Majority Leader, after consultation with the Democratic Leader, shall no later than September 29, 2006, or the last day of the second session of the 109th Congress, whichever is earliest, call up S. 295, a bill to authorize appropriate action if the negotiations with the People's Republic of China regarding China's undervalued currency are not successful; provided that if the bill has not been reported by then by the Committee on Finance it be discharged at that time and the Senate proceed to the consideration thereof; that there be 2 hours for debate equally divided between the Senator from Iowa (Mr. Grassley) and the Democratic Leader, or his designee, that no amendments or motions be in order, including committee amendments, that after the use or yielding back of time, the bill be read a third time and the Senate proceed to a vote on passage of the bill, with no intervening action or debate. (*July 1, 2005, Mar. 29, 2006.*)
