INSTRUCTIONS FOR COMPLETING FORM

Blocks 1,3,7,10,11,& 13: Self explanatory
 Block 2: Last four (4) digits of social security number
 Block 4: Dive Orders are required for NOAA Corps Officers: 1) at the beginning of each fiscal year (1 Oct); 2) when officers change duty stations; or 3) upon completing NOAA diving certification requirements.
 Block 5: Dive orders are valid for a maximum of one (1) year - ending at the end of the fiscal year (30 Sep). Enter this date or the last date of assignment with current unit/party/ship.
 Block 6: Enter the Line Office assigned
 Block 8: Signature of requesting officer if form is filled via hard copy
 Block 9: Date form is signed
 Block 12: Signature of immediate supervisor/commanding officer if form is filled via hard copy

INSTRUCTIONS FOR FILING FORM

This form may be filed electronically or via hard copy. If filed electronically, signatures are not required; however, the form must be forwarded to the NOAA Diving Center directly from the officer's immediate supervisor or commanding officer - as indicated by the e-mail address of the sender. If filed via hard copy, signatures are required for the requesting officer and immediate supervisor/commanding officer and the form may be mailed or faxed to NDC.
