# STATUTORY AUTHORITY TO WRITE FEDERAL DIVE REGULATIONS

NOAA divers are currently subject to two sets of diving regulations: the NOAA diving regulations and the OSHA commercial diving regulations. **OSHA regulations are extremely limiting for scuba operations**. Several years ago an official with OSHA recommended that NOAA consider conducting a formal rulemaking to adopt its own diving standards into the US Code of Federal Regulations which would allow NOAA to follow its own regulations and not OSHA's.

After a review of existing laws, as well as multiple discussions with Department of Commerce, Department of Labor, NOAA, and OSHA attorneys and staff, it was concluded that NOAA did not possess the statutory authority to promulgate regulations relating to workplace diving safety and health.

On December 26, 2007, President George W. Bush signed the Consolidated Appropriations Act of 2008 into law which included the following statement: "The Secretary of Commerce is permitted to prescribe and enforce standards or regulations affecting safety and health in the context of scientific and occupational diving within the National Oceanic and Atmospheric Administration." With this statement, DOC and NOAA now have statutory authority to publish and follow its own diving regulations.

The NOAA Diving Program has already started drafting language for the CFR that once completed, will be available for public comment prior to adoption.

This is a very exciting opportunity for the NOAA Diving Program that will ultimately: 1) provide a single, unified, and streamlined standard for NOAA divers, 2) incorporate all current industry techniques and technology, and 3) provide complete coverage for all the geographic locations in which NOAA conducts diving activities.

Please stay tuned for periodic updates on the progress of this exciting project.

### **Annual Medical History Forms Due**

Thank you to those divers who have already sent in their Annual Medical History Reports. NDC is in the process of reviewing them now. **These forms are due by March 1.** Many divers unnecessarily restate their past medical history on this form. The intent of this form is to obtain any NEW information from the past year for evaluation.

The NOAA Diving Safety Board meeting will take place at NDC, March 3-7. The top three agenda items are the proposed draft language for the CFR, a draft of the NOAA Diving Procedures and Policy Manual (replaces the NAO), and a review and revision, as necessary, of NDC's Strategic Plan. NDC encourages personnel to provide their Line Office/Fleet Diving Officer with discussion topics aimed at improving NOAA diving operations.

#### **Dive Pay**

Two new documents have been posted on the limited access website for NOAA divers, under Dive Pay Information.

Pay For Performing Dive Duties NAO-202-532A, effective January 25, 2008, establishes guidance for paying NOAA employees additional compensation for performing dive duties. It is a revision and retitling of the previously issued Order and supercedes NAO 202-532A, Scuba Diving Duty Pay During Training, dated August 13, 1992. It is a consolidated Order that classifies the four types of NOAA employees and describes their eligibility for dive pay.

Examples of Dive Pay Calculations Addendum NAO-202-532A is valuable for units in deciding how to pay their employees. Examples are provided for GS/GM and DOC Demonstration Project employees, Wage Grade employees and Wage Mariners.

#### **Annual Unit Inspections Due**

Annual inspections by units, sub-units and ships are required by the NOAA Diving program. This year, completed inspection checklists should be forwarded to the unit's (or ship's) LODO/UDS no later than March 15, 2008. The inspection checklist standardizes guidelines for the condition and requirements of dive units/lockers to ensure unit operational readiness and safety.
