SEAL IN DISTRESS

On June 8, 2004, NOAA divers Aaron King and Tom Laidig helped NMFS enforcement and California Fish and Game wardens search for a knife that had fallen out of a California sea lion. Someone had stabbed the sea lion, leaving the knife behind. Tourists watched the sea lion dislodge the knife near the Santa Cruz wharf. Aaron and Tom donned scuba gear and conducted a circular search pattern (using a 30 m line tied to a stake) in the area where the knife was last seen in an attempt to recover the knife for forensic analysis. They searched an area of 2,290 m², but were unsuccessful in locating the knife. The knife may have had enough buoyancy to float or to sink slowly, thus allowing it to leave the search area. As of this writing, the knife has not been located and the case will probably be closed.
