Northrop Grumman Awarded Contract **To Begin Work on U.S.** Coast **Guard's Maritime Security Cutter**

PASCAGOULA, Miss. -- June 30, 2004 -- Under the U.S. Coast Guard's Deepwater program, Northrop Grumman Corporation (NYSE: NOC) has been awarded approximately \$250 million in production and long lead material contracts for the first Maritime Security Cutter, Large (WMSL), formerly named the National Security Cutter, which is a highly capable high-endurance cutter. These contracts, awarded to the company's Ship Systems sector, bring the lead ship of the most advanced cutter class in the Coast Guard's fleet one step closer to delivery and leverage significant continued production savings across three different cutter classes by sharing the same design team, with common systems, logistics, and training.

The Ship Systems sector leads the construction effort as a major partner in Integrated Coast Guard Systems, a joint venture of Northrop Grumman and Lockheed Martin. The ship will be manufactured here at the Northrop Grumman's Pascagoula shipyard. Construction will begin in September 2004 with the keel laying to follow in April 2005. The anticipated delivery date for the lead ship is the second quarter of 2007.

The WMSL will be a 421-foot vessel with a 4,112-ton displacement at full load, when delivered, and will be powered by a twin-screw combined diesel and gas turbine power propulsion plant designed to cruise at a maximum speed of 28 knots. The cutter will include an aft launch and recovery area for two rigid hull inflatable boats, a flight deck to accommodate a range of rotarywing manned and unmanned aircraft and state of the art command and control electronics.

Integrated Deepwater System (IDS) is a critical multiyear, multibillion-dollar program to modernize and replace the Coast Guard's aging ships and aircraft, and improve command and control and logistics systems. It is the largest re-capitalization effort in the history of the Coast Guard. When complete, the interoperable IDS will include three classes of new cutters and their associated small boats, a new fixed-wing manned aircraft fleet, a combination of new and upgraded helicopters, and both cutter-based and land-based unmanned aerial vehicles. All of these highly capable assets link with command, control, communications, computers, intelligence, surveillance and reconnaissance (C4ISR) systems, and are supported by a new and far-reaching integrated logistics system.

Northrop Grumman Ship Systems includes primary operations in Pascagoula and Gulfport, Miss., and in New Orleans and Tallulah, La., as well as in a network of fleet support offices in the U.S. and Japan. design, engineering, construction and life-cycle support of major surface ships for the U.S. Navy, U.S. Coast Guard and international navies, and for commercial vessels of all types.

2004 Commandant of the Coast Guard National Retiree Council Meeting

The Commandant of the Coast Guard National Retiree Council (CCGNRC) held its third annual meeting in accordance with COMDTINST 1800.5D from 13 to 15 April 2004 at Coast Guard Headquarters. This was the inaugural meeting held by the CG for only the CG. In addition to the Co-Chairs, five chartered Regional Coast Guard Retiree Councils (RCGRC) were represented plus one representative from Mobile. There are eight RCGRCs, currently active with Mobile, going through the chartering process. Three representatives were unable to attend at the last moment: two due to travel problems and one due to illness. RADM Fred Ames, the incoming officer co-chair, also attended.

LT Howard Wright of G-IPA provided an overview of the Coast Guard's Engagement Plan and provided the council with an understanding of how the retiree community can help. From providing information on boating safety to telling the Coast Guard story, members of the CG retiree community through our regional councils are already assisting local commands providing speakers for public events, college fair nights at local high schools, and any other community and public service need. The CCGNRC co-chairs will maintain a close liaison with G-IPA and will provide assistance where the need arises.

The Council as a whole met with the Vice Commandant to get a sense of current Coast Guard issues. Vice Admiral Barrett reported that the Coast Guard is still "Semper Paratus!" He reported the Coast Guard continues its growth by 4,000 people and its budget increase by 10% per year. It has been a very busy year for CG personnel with the push to accelerate the DEEPWATER timetable and some 64% of the reserves on active duty. With regard to Secretary of Defense Rumsfeld's comment to "get the CG out of DOD plans," VADM Barrett does not see that happening, as the military leaders at the Pentagon depend on the CG to perform special missions around the world.

Mr. Tim Cox, COO, Armed Forces Retirement Home (ARFH), presented an update of AFRH. In FY 2002, the National Defense Authorization Act provided for: a name change, full time COO, elimination of the board structure, active duty military directors, a restructured resident fee schedule, and making the local boards advisory only. Now the AFRH is one organization in different locations with one set of standards, policies, and procedures. This is a giant step forward in elimination of duplication and waste! Coast Guard monetary contributive participation in the AFRH should be viewed in several positive and proactive ways. First, parity of our other DOD services. We remain as the only military service that does not contribute to the AFRH, thus giving us a "less than status." Secondly, this could be viewed as a possible option for long-term care for some of our enlisted members as they reach the 'golden years.' Finally, the contribution of \$6.00 per year per enlisted member and Chief Warrant Officer can also be viewed as a benevolent contribution, given that the vast majority of our service members may not take advantage of AFRH residency opportunities, yet they can assist in helping others. The Army, Navy, Marines and Air Force present this to their members as another opportunity to help take care of their own, particularly past veterans who have helped build the success of its service. The CCGNRC continues to believe that the CG should become a party to the AFRH.

The Military Coalition/Alliance briefed their priority legislative issues. These include SBP reform as the top issue. SBP reform involves three issues: (1) eliminating the SBP Age-62 Annuity drop (proposing new legislation for 10-year phase out of drop), (2) repeal the SBP-DIC offset, and (3) move paid-up SBP effective date back to 2004 from 2008 (those who signed up in early 70's). The other priority issue is expanding concurrent receipt for disabled retirees. The CCGNRC unanimously supports these legislative priorities as doing the right thing for our annuitants and disabled veterans.

The Council was briefed by Dr. Michael Doyle, program manager of the Coast Guard's Mentoring Program. Although the briefing itself focused on the active duty mentoring program, the discussion proved valuable in how the retiree community can proactively participate in assisting the active duty community through the Transition Assistance Program (TAP). Retirees may participate in TAP as guest speakers, or as added information resources on topics where they may currently be involved with through

New Medal Authorized Global War on Terrorism Expeditionary Medal (GWOTEM)

To recognize members of the Armed Forces of the United States, including Coast Guard Personnel (active duty and reserve),

Executive Order 13289, 12 March 2003, established a medal for service in or in support of Global War on Terrorism Operations, on or after September 11, 2001, to a future date to be determined by the Secretary of Defense.

Only one award of the GWOTEM is authorized per individual. No Service stars are prescribed. The GWOTEM may be awarded to the same individual if the member satisfies both criteria while serving in multiple roles during different periods of time.

The initial award to Coast Guard members is limited to personnel deployed abroad in Operation Enduring Freedom and Operation Iraqi Freedom in the following Department of Defense designated specific geographic Areas of Eligibility (AOE): Afghanistan, Bahrain, Bulgaria (Bourgas), Crete, Cyprus, Diego Garcia, Djibouti, Egypt, Eritrea, Ethiopia, Iran, Iraq, Israel, Jordan, Kazakhstan, Kenya, Kuwait, Kyrgyzstan, Lebanon, Oman, Pakistan, Philippines, Qatar, Romania (Constanta), Saudia Arabia, Somalia, Syria, Tajikistan, Turkey (East of 35 Degrees East Latitude), Turkmenistan, United Arab Emirates, Uzbekistan, Yemen, that portion of the Arabian Sea, North of 10 degrees North Latitude and West of 68 Degrees Longitude, BAB El Mandeb, Gulf of Aden, Gulf of Aqaba, Gulf of Oman, Gulf of Suez, that portion of the Mediterranean Sea East of 28 degrees East Longitude, Persian Gulf, Red Sea, Strait of Hormuz, and Suez Canal.

Coast Guard members must be assigned, attached, or mobilized to a unit participating in designated operations for at least 30 consecutive days or for 60 nonconsecutive days in the AOE, or meet one of the following criteria:

- Under circumstances involving grave danger of death or serious bodily injury from enemy action, regardless of time in the AOE.
- Be killed, wounded or injured requiring medical evacuation from the AOE while participating in designated operations.
- Be participating as a regularly assigned aircrew member flying sorties into, out of, within, or over the AOE in direct support of Operations Enduring Freedom and/or Iraqi Freedom. Each day that one or more sorties are flown in accordance with the criteria shall count as one day towards the 30 consecutive or 60 nonconsecutive day requirement.
- Coast Guard members operating in the United States are not eligible for the GWOTEM. The GWOTEM may be awarded posthumously to any Coast Guard member who lost their life while, or as a direct result of participating in global war of terrorism operations, without regard to length of such service, if otherwise eligible.

Requests for GWOTEM

Requests for award of the GWOTEM to veterans, retirees, or their next of kin should be submitted in writing to the National Personnel Records Center (NPRC).

Request should include a copy of the DD Form 214 and any other supporting documentation to substantiate service as outlined above.

RIBBON: Scarlet, white and blue represent the United States. Light blue refers to worldwide cooperation against terrorism. Gold denotes excellence.

OBVERSE: A bronze color metal disc charged with a shield adapted from the Great Seal of the United States surmounting two swords hilts to base saltirewise enclosed within a wreath of laurel; overall an eagle, wings displayed, grasping in its claws a serpent. The shield and eagle represent the United States. The swords denote readiness and the resolve to fight international terrorism, which is symbolized by the serpent crushed in the eagle's claws. The wreath denotes honor and achievement.

REVERSE: The eagle, serpent and swords from the front of the medal within the encircling inscription "War On Terrorism Expeditionary Medal."

Douglas Munro Memorial Cle Elum, Washington

Many of our members of the "Coast Guard Family" will be traveling this year and in the future. If your travels happen to take you on Interstate 90 in Washington State about 90 miles east of Seattle through the community of Cle Elum, make a brief stop and visit the Douglas Munro Memorial and VFW Wall of Honor. It is the final resting place of the Coast Guard's only Medal of Honor Recipient. He was killed in action in World War II and was awarded the Medal for heroic action rendered on Guadalcanal. The Memorial location is at Laurel Hill Cemetery on the west end of the town approximately three blocks northwest of the Safeway Plaza. The Douglas Munro Memorial has been designated a Washington State Historical Site thanks primarily to the efforts of one of our members of the Coast Guard Family, YNCS Everest Black (Ret) of Seattle, WA. Hopefully, one of these days we will have the Munro Memorial designated a National Historical Site as well.

I had the honor of being the principle speaker at this year's Memorial Day ceremony on 31 May. Attendance increases year after year due to the people that have been able to visit the Memorial while in route PCS or TAD, numerous retirees in their travels who stop to pay their respects, and at local events such as Memorial Day and Veterans Day. While passing through Cle Elum one evening a couple of months ago on my return from a trip to Eastern Washington, I made my usual "pit stop" at the Memorial site and found two Coasties visiting there. It is truly heartening to see that our hero is getting the recognition he deserves. If you visit the Memorial and have an extra few minutes, walk around the veteran section adjacent to the Munro Memorial and check it out. There is likely a "pilgrim immigrant story" associated with each one of those diverse names of veterans buried there.

The site looks splendid and is well cared for, thanks to Steve Jones, a life member of the local VFW Post, who does the "day to day" chores. Others that help are members of Douglas A. Munro VFW Post 1373, Seattle Chapter CPOA, Coast Guard Combat Veterans Association, and periodic visits by recently promoted Chiefs who are charged to pay their respects, write in their journal about the visit, and perform maintenance as directed by the Puget Sound Chief of the Mess. With all that help, we have most of our bases covered in maintaining the site in a pristine manner. Projects we have in the works are; providing a means of perpetually supplied flags for the Munro site, and in the future, plans to submit for consideration, a proposal for establishing National Historical Site status. It is an impressive memorial site for such a small community.

employment, volunteerism or experiences. One item of note is the newly formed Cape May regional retiree council is involved with the recruit training mentoring program, where retirees are sponsoring recruit companies. The CCGNRC will continue to openly and proactively support all CG mentoring program initiatives.

T-NEX is the TRICARE next generation of contracts and will transition this CY with the goal of seamless transfer of claims data from outgoing to incoming contractors. The administration of TRICARE will be greatly enhanced with a significant reduction of regions and contractors from eleven (11) and seven (7) to three (3) and three (3) respectively. TRICARE management expects the new system to be easier to access, more customer service focused, and more responsive to patients. The changeover should be transparent to most. However, as with any change to such a massive system, we may very well experience a few changeover issues, likely to be on a case by case basis. The Military Coalition will be monitoring this carefully, as will CG Health Services. All retirees who use TRICARE should be made aware of the change and be on the alert for potential provider or claims processing issues. As always, use the Health Benefit Advisor (HBA) hotline as soon as any problems are detected: 1-800-9HBA-HBA (1-800-942-2422).

Recruiting Initiative Update: Coast Guard Recruiting Command (CGRC) personnel updated the CCGNRC on enlisted personnel recruiting with emphasis on the effectiveness of the SMART initiative. They re-emphasized the Partnership for Success opportunities for RCGRCs to establish points of contact with the local recruiting offices through the CGRC, and to assist the Coast Guard to aggressively pursue its diversity recruiting goals through focused and streamlined efforts in selected areas nationwide. In addition to fostering development of new enlisted recruits, reserve enlisted recruiting is also aligned with the SMART initiative. Details on both the enlisted and officer-recruiting programs are posted on the CGRC Web-site (www.gocoastguard.com).

COMPASS is a diversity outreach program to increase awareness of the CG in local communities and is distinct from recruiting. See 'COMPASS Outreach' on page 11.

The CCGNRC received a PowerPoint from Military Advantage, Inc, which runs and maintains the widely acclaimed website, http://www.military.com/. The site itself, which has over 3 million registered members is a clearing house of internet access to virtually hundreds of links that are of interest to all members of the military community, including active, reserve, retired, veteran, family member and civilian employees of the military services. Most importantly, the site has created a Mentoring Network system, which allows members to link with people either employed or connected to an organization or occupation, as well as specific to each military service. The site includes opportunities for retirees and veterans to create unit 'home pages' for reunion announcements, and as a way to keep in touch with former colleagues and shipmates. Also, the site has direct links to all military information news sites, military benefits, and career information. The CCGNRC intends to make use of this site to help build a mentoring network among retirees who volunteer to provide members of the Coast Guard family transition assistance (relocation resource), and keep abreast of Coast Guard and other military news.

The Chief, Office of Security Policy and Management presented the new CG Vehicle Decal security system. Due to the requirements for increased security (post-9/11), the old decal system has been scrapped and replaced with a system that is "needs" based. See 'Privately Owned Vehicle Decal Program' on page 10.

D5 Commodore Donnie Karpman provided a general brief on the CG Auxiliary. While the briefing was especially informative, we had anticipated a follow up to the presentation last year by CDR James Welch, focusing on how retirees can be enabled to readily join the Auxiliary. Apparently we did not convey the specifics of our interest to the Commodore in preparation for his visit. RADM Ames will meet with the National Commodore to clarify our interest in further developing mutual recruiting/accession strategies.

The Navy Mutual Aid Association (NMAA) provided a highly informative presentation on insurance; covered the different types of insurance vehicles including Long-Term Care (LTC). They provide a similar presentation to retiree seminars throughout the country and is available to local CG chapters. Retiree chapters are encouraged to contact NMAA as soon as they schedule seminars for possible inclusion on their agendas. Especially noteworthy issue is that widows who remarried after age 57 now have a window of opportunity to regain lost DIC, but need to register by December 15, 2004.

CCGNRC Initiatives:

Supporting the CG Band through an award/recognition program. One of the items noted in attending briefings of the a. other services' retiree councils are their involvement with sponsoring recognition award programs for their ceremonial honor guards and military bands. These particular groups are chosen because of the distinction of their roles as unique visibility representing their services. The Military Advantage, Inc. has offered such an opportunity for the Coast Guard Retiree Council to sponsor an award to the Coast Guard Band. Upon contacting the band in September of 2003, they put together criteria to establish a "bandsman of the year" program and named it the "Sam Hasty Award" in honor of MU1 Sam Hasty who passed away in 2002 from cancer, and was seen as a personal inspiration to the band members in his ability to work tirelessly through his illness and his spirit of motivating others to not give up. Are you or someone you know eligible to enroll in Medicare Part B, but you haven't due to the premium surcharge you would have to pay? We have good news for you!

What's New with Medicare Part B?

One of the provisions of the Medicare Prescription Drug, Improvement and Modernization Act of 2003 allows uniformed services beneficiaries who would be eligible for TRICARE For Life (TFL) but are not enrolled in Medicare Part B to enroll without penalty during an open enrollment period through **31 December 2004**. An open enrollment letter will be sent to those Medicare-eligible beneficiaries who don't currently have Medicare Part B.

Who's eligible?

- Medicare-eligible retirees, including retired National Guard and reservists
- Eligible qualifying family members and survivors
- Certain former spouses if they were eligible for TRICARE before age 65, and who have not remarried and do not have employersponsored other health insurance
- Dual-eligible beneficiaries under the age of 65 who are entitled to Medicare Part A because of a disability or because of endstage renal disease

TRICARE Management Activity is working with the Centers for Medicare and Medicaid Services (CMS) and Social Security Administration to send uniformed services beneficiaries targeted information on Medicare Part B open enrollment. Eligible beneficiaries will not be required to take any action; there will be an automatic enrollment by mail. Upon receipt of the enrollment letter from Social Security Administration, Medicare-eligible beneficiaries will be given the opportunity to choose any month in 2004 for their Medicare Part B enrollment.

They also will be given the option to refuse Medicare Part B, or if they currently have other health insurance, they will have the option to wait until a special enrollment period to enroll.

The Medicare Prescription Drug, Improvement and Modernization Act of 2003 also includes a provision for beneficiaries who enrolled in Medicare Part B between January 2001 and December 2004 and are subject to a penalty for late Beginning January 2004, these enrollment. beneficiaries will have the penalty waived. Beneficiaries who enrolled in Medicare Part B in 2004 and have paid a premium surcharge will be eligible for a rebate. TRICARE Management Activity is working with the Centers for Medicare and Medicaid Services (CMS) and the Social Security Administration to send a mailing to individuals who enrolled in Medicare Part B between January 2001 and December 2004 to notify them of the penalty waiver. information including recruiting, CG Auxiliary, etc.d. Regional retiree councils will also continue to work closely with their sponsoring unit assisting in relocation efforts of newly arriving CG personnel to the area, as well as those who are transitioning.

Coast Guard For'er. Last year we reported on a new Marine Corps program called Marine For Life (M4L). The M4L Program is designed to expand transition assistance and provide sponsorship for the Marines who honorably leave active service and return to civilian life. Marines serving in local communities throughout the Nation will act as sponsors for transitioning Marines by providing information and points of contact for employment opportunities, housing, education, and other matters. The M4L Program formally extends their commitment to "take care of our own" and nurtures mutually beneficial relationships inherent in the Marine ethos "Once a Marine, Always A Marine." The members of the CCGNRC unanimously endorse it to be an excellent model for the Coast Guard to adopt. We recommend the Commandant be briefed on a possible CG version of the M4L program that we have labeled "Coast Guard For'er!"

The Regional Council representatives shared their council activities with the group. It was noted that each of the active councils continues to enjoy a high level of support from their sponsoring commands. Getting pertinent and useful information to their retirees and annuitants is a priority for all the Councils. All produce a local newsletter (either printed or electronic) from two to four or five times each year and meet as a council just as frequently. They all remain "Semper Paratus" to help the active CG where possible. The topic of new charters was discussed. It was agreed that new charters would be issued to the existing Regional Councils that comprised the first meeting of the National Council in 2002 using the date of the new COMDTINST 1800.5D as the charter date (Jan. 13, 2003).

MCPOCG Patton, USCG, (Ret) attended the USAF Retiree Council meeting 4-7 May 2004 at Randolph AFB, TX. While their subject area was similar in nature to all other military service retiree councils (TRICARE, Commissary & Exchange updates, Retiree Dental program, legislative updates) there were a few items of note to include in this report of interest to the Coast Guard. USAF Retiree Activities Office (RAO) assists a significant number of CG retirees and annuitants.

- a. Briefing on "My Pay" from the Defense Finance and Accounting System (DFAS), addressing a new initiative to allow retirees and annuitants to make online changes to their pay account such as allotments, change of addresses, state and federal tax withholding, and access to form 1099Rs and earning statements when needed. Currently only 22% of the AF retirees are taking advantage of this program. The emphasis is placed to increase this number over the next year.
- b. DFAS is also building a retiree email address book, similar to our "global" address system. In addition, DFAS will begin doing allotments for TRICARE Prime payments on 1 Sept 2004.
- c. The USAF has officially termed "Airman" [emphasis on the capital 'A'] to represent all members of the USAF team, active, reserve & civilian members.
- d. The "Air Force Village" is a long-term independent and custodial care living facility open to widows/widowers of retired officers representing all branches of the armed services. Priority is given to USAF annuitants first. The village does have a Coast Guard annuitant as a resident.
- e. The "Air Force Enlisted Village" is the enlisted equivalent of the 'Air Force Village.' It too has a Coast Guard annuitant as a resident.
- f. The Air Force Chief of Staff, General John Jumper designated the "Charity Ball" which is done annually at Bolling AFB, with proceeds going to the Air Force Aid Society (equivalent to the CG Mutual Assistance Program). Over \$200K was raised at the 2003 ball.

FAIRWEATHER, Reactivated After Fifteen Years.

The NOAA Ship FAIRWEATHER is a hydrographic survey ship, originally commissioned with NOAA in 1968 and deactivated in 1989. But a critical backlog of surveys for nautical charts in Alaska, where FAIRWEATHER will operate, was a motivating factor to reactivate the ship. "The FAIRWEATHER will bring a much-needed capability to the tremendous survey backlog in Alaska waters. I know Ketchikan will give a warm welcome to the vessel and the NOAA families attached to it," said Senator Ted Stevens (R-Alaska). The 35-year old ship has been tied up at NOAA's Marine Operations Center - Pacific in Seattle, Washington.



The ship will be equipped with the latest in hydrographic survey technology – multi-beam survey systems; high-speed, high-resolution side-scan sonar; and an on-board data-processing server.

The FAIRWEATHER is named for Mt. Fairweather in southeast Alaska. Mt. Fairweather is the highest peak in the Fairweather Range, which is the tallest coastal range on earth. The vessel is operated by NOAA Marine and Aviation Operations. It has now officially resumed its position in the NOAA fleet, and began hydrographic survey operations on 23 August, FAIRWEATHER was built in the late 1960s, and was deactivated in 1988 because of budget cuts. It was briefly reactivated in 1989 after the Exxon Valdez oil spill to serve as a command post in Prince William Sound for NOAA and other agencies working to mitigate the damage there. After sitting idle for 15 years at the Marine Operations Center-Pacific, the ship was towed to Cascade General in Portland, Oregon, and was refurbished and outfitted with new technology over a period of 18 months. The ship is now multi-mission capable, and will conduct some fisheries and oceanography research in addition to its primary mission-helping RAINIER reduce the 9700 square-nautical-mile backlog of critical survey areas.

I am delighted to have this important NOAA asset back in the fleet, and offer best wishes to Commanding Officer CDR John Lowell, his officers, and crew as they get underway.

On the plus side, being listed on the CG Home page has enabled us to help out a number of retired individuals over the last year and to get the word out to our Council members. VA to Begin Chiropractic Care

WASHINGTON – Veterans can receive chiropractic care at 26 selected Department of Veterans Affairs (VA) facilities beginning this fall, Secretary of Veterans Affairs Anthony J. Principi announced today.

VA will hire or contract with doctors of chiropractic to provide the care. In consultation with VA primary care providers, doctors of chiropractic will offer patient evaluations and chiropractic care for neuromusculoskeletal conditions.

"Today, VA makes another significant improvement to the world-class health care we provide for eligible veterans," said Principi. "Veterans who will benefit from chiropractic services will now have the opportunity to receive chiropractic care to restore them to good health."

Locations where chiropractic care will be provided include Togus, Maine; West Haven/Newington, Conn.; Buffalo and the Bronx, N.Y.; Butler, Pa.; Martinsburg, W.Va.; Salisbury, N.C.; Augusta, Ga.; Tampa and Miami, Fla.; Mountain Home, Tenn.; Columbus, Ohio; Danville, Ill.; Iron Mountain, Mich.; Kansas City, Mo.; Jackson, Miss.; San Antonio, Temple and Dallas, Texas; Albuquerque, N.M.; Phoenix, Ariz.; Fort Harrison, Mont.; Seattle, Wash.; Martinez and Los Angeles, Calif.; and Sioux Falls, S.D.

Eligible veterans in areas distant from these locations will also be able to receive chiropractic care through VA's outpatient fee-basis program after a referral by their primary care provider, and prior authorization by the department.

VA was authorized to offer chiropractic care and services under the provisions of section 204 of Public Law 107-135, the Department of Veterans Affairs Health Care Programs Enhancement Act of 2001. Chiropractors seeking employment or to provide contract services to veterans should call the Human Resources office of any of the above facilities. Privately Owned Vehicle (POV) Decal Program

The Coast Guard has undertaken to improve its Privately Owned Vehicle Decal Registration Program. These revisions are one component of an overall effort to enhance USCG Security. To promulgate these changes. The Coast Guard recently published ALCOAST 151/04, and Change 1 to the Physical Security and Force Protection Program Manual CIM5530.1C.

Originally the vehicle decals were designed to prove ownership and ensure proper registration, insurance, and the like. They have evolved over time, particularly since 9/11, and are perceived as an integral part of facility security. In view of the dramatic increase in external threat to all U.S. Government facilities, enhancements to current security measures are considered prudent. Improvements in access control, including the Decal Program, are one of the key features of the overall Internal Security Program that protects Coast Guard installations and assets.

The new Decal Program incorporates several changes

and all units will be required to request authority to issue decals.

To qualify as an Issuing Authority, a unit will need to have access controls in place at their installation. Furthermore, they will be expected to use the CG decal as one of their access control measures. The new CG Decals will be centrally managed, at the CG Security Center located in Chesapeake, VA. A full time manager has been designated to expedite the process, and centrally manage the web-enabled database. This electronic management tool will better monitor the issuance and disposition of CG Vehicle Decals. It will facilitate the tracking of decals throughout their life cycle, from printing, through unit and individual issue, and eventual destruction.

The new Decal Program processes and procedures will dramatically improve decal accountability, and thereby limit the risk of unauthorized access to our installations. The result will be enhanced internal security that better protects our people and property. Source: ALCOAST 151/04

COMPASS Outreach Points Toward Recruiting

After the terrorist attacks on 9/11, Armed Forces Recruiting Offices, including those of the Coast Guard, started receiving calls from retirees who desired to return to active duty to do their part to help fight the war on terror.

"My office started receiving calls within the first few days after the attack," said SCPO Frank Burgess a former recruiter-in-charge at Recruiting Office Dover, Delaware and currently a sector supervisor at the Coast Guard Recruiting Command.

"I didn't have anything for them," said Burgess, "we weren't growing at that time nor had we depleted our ranks." Since that time many retirees are still eager to volunteer their time for the Coast Guard to help get the word out.

One such program that has seen growth from these volunteers is the COMPASS Diversity Outreach Team. This program is made up of volunteers throughout the country who are committed to increasing awareness of the Coast Guard in diverse communities.

The COMPASS team is comprised of active duty, reserve, civilian, auxiliarist, and retired Coast Guard members. There are currently more than 160 members throughout the country, with new members constantly being added.

COMPASS team members focus on outreach. As community members become more aware of Coast Guard missions and opportunities, the number of people interested in Coast Guard careers is expected to increase as well. Ultimately, COMPASS outreach efforts should lead to an increase in the number of people recruited.

"We want to ensure that COMPASS team members and local recruiters are collaborating so that communication with local schools and other venues is well coordinated," said LCDR Necia Chambliss, COMPASS manager. Chambliss also said COMPASS team members will be contacting recruiters in their local area, and encouraging them to contact local COMPASS members as well.

"In areas where you have already established a strong relationship with a particular school or organization, the COMPASS member will be available to assist you on an as needed basis," said Chambliss.

In addition to assisting recruiters, team members conduct outreach activities primarily in their own communities. Members conduct see 'COMPASS Outreach' on page 12

many types of outreach activities, such as speaking at high schools and colleges, staffing booths at community events such as Pow-Wows and cultural festivals, and speaking to Girl Scout Troops, Chambliss added.

"By utilizing our own Coast Guard members who are already deeply rooted in their own local communities, we are able to build bridges with people throughout the country that have otherwise been unreachable," said Chambliss.

One such community is the town of Dillsboro, IN population 1,200 and home of CWO William Redwine who retired in 1987. Although he may not be wearing Coast Guard blue any longer, Redwine was eager to volunteer for the program and help with Coast Guard recruiting and awareness.

"I was interested in helping out because anytime, anyplace, anywhere you can promote the Coast Guard – you do it," said Redwine. If you, like Redwine, are ready to get out there and help promote and recruit for the Coast Guard, if you have events that you need assistance with, or if you are aware of valuable outreach opportunities that you cannot attend, a member of the COMPASS team may be able to assist you.

The USCG Cutter TANEY, The Last Surviving Warship from the Attack on Pearl Harbor

The morning of 7 December 1941 found TANEY at her home berth of Pier 6 near Honolulu's Aloha Tower. Shortly before 0700 the cutter's radio room copied an unusual message: the USS WARD reported that it had attacked and sunk an enemy submarine in the approaches to Pearl Harbor. Sensing from the message a dramatic turn of events, the Officer on Deck (OOD) on duty that morning immediately recalled all officers from shore and had the crew stow the ship's deck awnings, remove gun covers and bring up ammunition from the magazine. After clearing the ship for action the Coast Guardsmen waited.

Suddenly, around 0800, the sky to the northwest came alive with anti-aircraft bursts as Navy ships commenced a frantic defense of Pearl Harbor some eight miles away. Commander Louis B. Olson, USCGC TANEY's Captain, gave the order to sound General Quarters and then called for steam in preparation for getting underway. Olson later reported that the ship's "anti-aircraft battery as well as all other guns were ready to fire... within four minutes." As the battle raged, the sky over the fleet anchorage turned black from the smoke of burning ships and TANEY's crew waited for a chance to open fire should enemy planes approach Honolulu. An hour after going to battle stations, several scattered formations of Japanese planes came overhead and Commander Olson gave the order to commence firing. On TANEY's fantail, the ship's two 3"/50 anti-aircraft guns went into action firing some 27 rounds of shrapnel ammunition at the raiders whose distance and altitude was just outside effective range.

During the morning, confusion reigned as Japanese aircraft not only attacked Battleship Row and the adjacent facilities, but also hit Army, Navy and Marine Corps installations throughout Oahu. While the bulk of Japanese aircraft had completed their attacks by 1000 hours, small groups of planes continued to appear until almost Noon. At Pearl Harbor, Japanese bombers were fired on by a number of US ships between 1100 and 1135 hours.

TANEY's crew remained at battle stations throughout the morning in case the raiders reappeared over Honolulu. Finally, just before noon, the cutter's gun crews were able to engage a target at close range. "At 1158," reported Commander Olson, "a formation of five enemy planes approached the vessel directly from the south southwest over the harbor entrance on what appeared to be a glide bombing or strafing attack on the power plant north of the vessel's berth at Pier 6." TANEY's guns opened up on the planes which were "rocked by the fire and swerved up and away." Commander Olson was able to report that "Several .50 cal. tracers appeared to pierce the wing and tail structure of one plane," before the attackers changed course to avoid the barrage.

"The officers and crew," reported Commander Olson in the wake of the attack, "bore themselves well although most members of the crew had no training except drill and had never seen anything above a .50 caliber fired."

Tricare South Region to begin Transition August 1

The Department of Defense (DoD) today announced the continuation of its transformation to new military healthcare contractors and changes in regional areas of responsibility.

On Aug. 1, 2004, Tricare-eligible beneficiaries in Alabama, Florida, Georgia, eastern Louisiana, Mississippi, South Carolina and Tennessee transition to the Tricare South Region. These locations formerly comprised the Southeast and Gulf South Regions (Regions 3 and 4). This is the third major transition to new regions and new contracts announced by the department, including the initial transition of parts of the West Region on June 1 and parts of the North Region on July 1.

According to Dr. William Winkenwerder Jr., Assistant Secretary of Defense for Health Affairs, "Through these new and competitively awarded contracts we offer our beneficiaries a suite of services that provide the highest quality of care and a high level of customer service. These qualities of Tricare also make it a world-class, value-added benefit of military service."

Tricare benefits, costs and the enrollment process remain the same under the new regional contracts. Beneficiaries in the South Region who are not currently enrolled in Tricare Prime, but who are eligible and residing in a Prime area, will have the opportunity to enroll. Humana Military Healthcare Services Inc. will provide beneficiaries information on enrollment, network providers, procedures for filing claims, and contacts for assistance in the South Region.

Beneficiaries in Arkansas, the remaining part of Louisiana, Oklahoma and Texas, except for the far Western part of the state, will complete the Tricare South Region when they transition on Nov. 1, 2004.

Military treatment facilities (MTFs) in all regions remain at the core of the military health system and will now schedule appointments for their beneficiaries. MTF locations are on the Tricare Web site at http://www.Tricare.osd.mil/mtf/.

The new Tricare contracts build on the best aspects of a system developed over the last 10 years, making a strong program even better and by providing incentives for improvements in quality care, access and claims payments. DoD also has awarded additional specific contracts for mail order pharmacy, retail pharmacy, retiree dental care, the Uniformed Services Family Health Plan, Tricare Global Remote Overseas, Tricare healthcare for Puerto Rico, marketing and education programs, information services, and national-quality monitoring, and claims processing for Medicare-eligible beneficiaries.

Humana Military Healthcare Services Inc., a wholly owned subsidiary of Humana Inc., has worked with the DoD as a Tricare regional managed care support contractor since 1996. Under the next generation of Tricare contracts, Humana will provide healthcare services and support to the approximately 2.86 million beneficiaries in the new Tricare South Region. What is the difference between Veterans Day and Memorial Day?

Many people confuse Memorial Day and Veterans Day. Memorial Day is a day for remembering and honoring military personnel who died in the service of their country, particularly those who died in battle or as a result of wounds sustained in battle. While those who died are also remembered on Veterans Day, Veterans Day is the day set aside to thank and honor *ALL* those who served honorably in the military - in wartime or peacetime. In fact, Veterans Day is largely intended to thank *LIVING* veterans for their service, to acknowledge that their contributions to our national security are appreciated, and to underscore the fact that all those who served - not only those who died - have sacrificed and done their duty. Why are red poppies worn on Memorial Day, and where can I obtain them?

The wearing of poppies in honor of America's war dead is traditionally done on Memorial Day, not Veterans Day. The practice of wearing of poppies takes its origin from the poem "In Flanders Fields," written in 1915 by John McCrae. For information on how to obtain poppies for use on Memorial Day, contact a veterans service organization, such as the Veterans of Foreign Wars of the United States (VFW), as the VFW distributes poppies annually on Memorial Day. WWII VETERANS OUTREACH

This year marks not only the 214th anniversary of the founding of our service, but also the official observance of the 60th anniversary of World War II. The Coast Guard's role in WWII began in 1939 enforcing the country's neutrality. Ultimately 241,000 men and women of the greatest generation served in the Coast Guard during that war.

August 4th began a yearlong campaign to record the oral histories of our World War II Veterans with the Library of Congress veterans' oral history project, http://www.loc.gov/folklife/vets/. We are publicizing this effort, to encourage our service WWII veterans, SPARS, Merchant Marines, and their families to enter their stories via the Internet. Additionally, Coast Guard auxiliary public affairs officers nationwide have volunteered to capture the reminiscences of those veterans who do not have access to the internet.

TriWest and TRICARE: What's the Difference?

During the time that TriWest Healthcare Alliance has been in existence, we have noticed that many people find it hard to understand the difference between TriWest and TRICARE. Each name starts with the same three letters, and even the logos are similar.

To understand what TriWest is, you first have to understand TRICARE. TRICARE is the managed care program of the U. S. Department of Defense (DoD) that was created in the early 1990s as a better way to provide health care services for active duty military personnel and their families and for military retirees and their families. It receives its funding as part of the annual defense budget, which is approved by Congress and signed by the President.

TriWest Healthcare Alliance is a DoD contractor, a management service organization-one of several private organizations that administer the TRICARE program in various regions of the United States and abroad. It is not an insurance company and should not be described as such. The <u>TRICARE Central Region</u>, which is TriWest's area of responsibility, is made up of 16 states, or parts of states, from Minnesota to Nevada and from Montana to El Paso, Texas.

I am writing concerning the picture on the last page of the July-September Evening Colors issue. The bell certainly looks

like one that was used on large bell buoys. They were approximately 2-1/4 foot tall and 3 foot at the largest diameter and weighed 1,000 pounds. Perhaps the buoy to which the bell was attached broke loose from its moorings and drifted ashore on Isla Cozumel. It is not unusual for buoys to end up thousands of miles from their original location. Some East Coast buoys have drifted to England and the Mediterranean.

I think it's from a bell buoy that slipped its mooring and washed to a beach in Mexico. I know some bells were engraved U.S.C.G. and I think a date also. James P. Lawson BMCM Ret, N.C.A

My neighbor has one of these bells, "USCG" and "1972", out by his flagpole and the Long Island Maritime Museum (West Sayville, NY) has two bells ("USCG" and LHS"), I don't know the dates.

My neighbor's bell was recovered by his son, now a former 180' buoy tender C.O. I believe that these three bells and the "Mexican" bell are all from buoys, not vessels.

I drove to the LIMM to gather additional data re the two buoy bells on the site. One is: "USLHS" "1931". The other bell is: "USCG" "1942". (The U.S. Light House Service became part of the Coast Guard in 1939.) I looked up the 180' buoy tender captain and he did confirm that we are looking at floating aid to navigation bells. The one in front of his dad's house shows the four clapper marks of a gong buoy. The two bells at the museum do not show clapper marks; therefore, they are probably bell buoy bells. *E J Neale*

These comments are from an American friend of mine, who lived in Cozumel part time for many years. He even learned to speak Mayan, so you can see he was in a position to know more about the local history than the average tourist.

"Luis de Hoyos had the anchor and two bells in front of his house. He told me that he had salvaged them from light house ships which had been sunk by the Germans on Chinchorro reef, about fifty miles or so southwest of Cozumel. Luis told me that the Germans had a submarine, which was based out of the south end of Cozumel. This boat's job was to impede (sink) traffic east of the Panama Canal. Sinking the lighthouse ships was part of this.

The U.S. Army set up an Air Corps base on the island, about where the present airport is now. This required that some of the town of San Miguel be moved to its present location, further south. In spite of the Army Air Corps' daily flights, the submarine was not caught until almost the war's end. Luis said that it was finally bombed and remains in fairly shallow water on Chinchorro Reef. I wanted to dive on it, but ultimately didn't try to find it."

We generally believe that "light ships" were Coast Guard vessels. That's the possible explanation for the observations of CDR Sumner. I hope the USCG historian can add specifics to this. C. S. (Nick) Ferris, CDR, USCGR, Ret.

While visiting my Dad, I read, with interest, an article in "Evening Colors" on CDR Stewart Ross Graham. [the first helicopter pilot to use a helicopter hoist to rescue survivors] My Dad has a photo that hangs on his wall of the first USCG helicopter hoist. The photo was taken at the USCG Air Station, Traverse City, MI, 1948. The hoist was developed by my Dad, ADC Kenneth Gradom Mac Petrie USCG, Ret, and Chief Matlana. They worked long and hard on it and Dad hit the tarmac many times. The hoist was then taken to D.C. by a couple of officers. I have the pleasure of knowing my Dad saves lives everyday. WHY DON'T WE HAVE A REUNION?

BILL MADIGAN gave up his search for an old shipmate when told that he'd died in a car crash. Since nearly half a century had passed, he wondered if he'd ever see his Coast Guard buddies again. But when a miracle answered his question, it also slapped him with a challenge that could brighten the days of us all.

Miraculously, the name of his dead buddy suddenly showed up on the Internet. Could it be the same guy? Was he alive? He sent an email message. It was indeed his buddy. A few weeks later they were sitting in a bar, reliving the good old days and feeling like teenaged sailors again. At his home, a dusty box from a closet yielded more memories. Old photos resurrected more and more shipmates. "Let's see if we can find them." Madigan urged.

On the Internet, a familiar name showed up in a phone directory for a nearby state. They dialed the number and asked, "We're you on the Rockaway?" The voice answered, yes. Ten calls later they'd found more shipmates. Those shipmates knew where more shipmates were. "Wow," said Madigan, "Why don't we have a reunion?" But hundreds of worries assaulted them. Would hotels give them discounts, so more guys would show up? If they didn't show up, who'd pay the hotel? Just before they threw up their hands, the wife of a shipmate came to their rescue. With experience in tourism, she volunteered to show them how a reunion is run, if they'd hold it in nearby Orlando. They agreed.

Evening Colors agreed to print their announcement, and veterans magazines followed suit. They built a web page on the Internet, to have a central meeting place. As new shipmates logged in, they added missing pieces to the final days of their cutter, with photos to back it up. Old rumors died when a photographic history of their cutter was finally published on their site.

The Rockaway, as many believed, did not lie in a watery grave. She had not been the target of a naval gunnery drill. Nor did she any longer sail the seas. She was now a ghost ship. She'd left this world the same way she came in.


Each discovery led to more discoveries. They were not the first to sail her. She had first belonged to the Navy. More announcements appeared in more magazines, as they invited the Navy crews to join them in Orlando. Incredibly, though the Rockaway had been built just before the attack on Pearl Harbor, Navy crewmen responded. They even heard from a shipmate on the very first crew of the Rockaway: a plank owner, who had joined the Navy at the age of 15. He, too, was coming to the reunion.

The big event finally came and went. With all the emotions, from laughter to tears, everyone voted to do it again. Its success also opened eyes. For the first time they'd seen the power of reunions. The power to revive the spirit, and the power to bargain.

Now planning their third reunion, the Hilton DoubleTree in Phoenix is giving them 2-room suites for half price, with full-breakfast buffets every morning, free. Since the Rockaway rate is also good for 3 days before and after the reunion, shipmates are stretching it into 10-day vacations in the Grand Canyon State at never-before seen bargain prices. For those flying to the reunion, airlines, too, are offering discount fares.

But bargains, they insist, are only a bonus. The soul of a reunion is the bond it renews. They'd once again become a band of brothers. No one, they realized, should miss out on this. That's why they've opened their reunion, for the first time, to brothers from sister cutters, to see first hand why they, too, should ask, "Why don't we have a reunion?"
