The minutes of the 3rd Quarter FY06 Aviation Safety Board were approved by the Council.

#### OLD BUSINESS.

LCDR Barr briefed the board on the current NOAA Aviation Safety Program. The presentation is included as attachment #1. The following comments were made by LCDR Barr (except as noted) and pertain to that briefing:

- Slide #2 The Aviation Safety Program office is developing the Qualified Non-crewmember Safety Program for safety board approval. Qualified non-crewmembers will be issued a flight qualification card indicating the types or flight operations the individuals have been trained to participate in with training expiration dates. (Action LCDR Barr; Suspense none; Status Info)
- Slide #4 Remaining action item ASP will work with AGO & NOAA GC to draft language for website. (Action LCDR Barr; Suspense 22 Aug 06; Status Open)
- Slide #6 NAO 209-124 being routed for signature; still needs to clear NOAA GC, PA&E, DUS, COS and the Undersecretary. (Action LCDR Barr; Suspense none; Status Info)
- Slide #7 The Policy becomes effective October 1st, 2006; still operating under interim guidance memo. (Action LCDR Barr; Suspense none; Status Info)
- Slide #11 Medical screening database expected to be accessible 1 September. Several board members expressed concern about the short time-frame for all medical screening to be accomplished (by 1 October 2006). (Action LCDR Barr; Suspense 1 Sep 06; Status Open)
- Slides #12&13 A question was raised by a board member about clearance to use other government aircraft. LCDR Barr stated that government aircraft will not be listed in the data base but are approved by the exception in NAO 209-124 Section 6, Paragraph .02d. (Action LCDR Barr; Suspense none; Status Info)
- Slide #16 Concern was expressed about Line Office (LO) personnel being trained by 1 October, 2006, when LO's have not budgeted for this training. A question was raised about the cost associated with this training: the ASP will provide cost info on website for training vendors. (Action Mr. Eisenbraun; Suspense 1 Jun 06; Status Open)
- Slide #17 LCDR Barr emphasized that line office reps to safety board need to communicate with LO personnel to ensure med screening & training will be accomplished before 1 October 2006. The question was raised about estimated percentages of personnel currently trained. NMFS believes approximately 75% currently trained. (Action LCDR Barr; Suspense none; Status Info)

Slide #18 - LCDR Barr will work with OR&R and other emergency responders to develop procedures for quick waiver request review. (Action - LCDR Barr; Suspense - 1 Oct 06; Status - Open)

Mr. Eisenbraun briefed the board on the progress of the water survival training. The presentation is included as attachment #2. The board discussed the merits of using the full cockpit trainer for initial training and decided that line office managers will decide the appropriate trainer to be used based on mission and risk assessment. (Action - Mr. Eisenbraun; Suspense - none; Status - Closed)

The board reviewed and unanimously approved the training standards as proposed in Mr. Eisenbraun's briefing. The standard of training will be posted on the website along with a list of training vendors that meet the approved standards. A spreadsheet listing the approved vendors is included as attachment #3. (Action - Mr. Eisenbraun; Suspense - 1 Jun 06; Status - Open)

#### NEW BUSINESS.

LCDR Barr presented Gary Eisenbraun to the board. Mr. Eisenbraun will serve as the new Aviation Safety Program Analyst. (Action - LCDR Barr; Suspense - none; Status - Info)

LCDR Barr introduced a proposal to create a "Limited Flight" category that would allow up to two flights on mission operations flight that would not require aviation safety training. Board discussion centered on the possibility that the introduction of new terminology not currently listed in the NAO would create confusion. It was thought that a revision to the definition of "Observer" program might allow for the same outcome. The board decided that no change to current policy would be made while the NAO is being routed for signature but that the issue may be raised again in the future. (Action - LCDR Barr; Suspense - none; Status - Closed)

The meeting ended at 1430 hours.

The next meeting is tentatively scheduled for 22 August 2006.
