Bankruptcy Release 3.1

This document summarizes the changes you may notice when you use CM/ECF in a U. S. Bankruptcy Court that has installed Release 3.1 of the application. Note that what you see in a particular court may be different from what is described here.

Case Opening

- The initial screen for <u>bankruptcy</u> cases now has a "Main/Nonmain" selection (for Chapter 15 cases only).
- A new "SumSchTotal" DPF can be used in lead events to display a screen for the entry of items from the Summary of Schedules.
- If a deficiency list is displayed (DisplayDeficList DPF) during the docketing of the lead event, a check is made between any items selected and the data supplied on the Summary of Schedules (assumes that the SumSchTotal DPF preceded DisplayDeficList) e.g., if figures for Schedule A are entered on the Summary, and the user marks Schedule A as being deficient, an error message is displayed.
- A "Bankruptcy party" item now appears on the screen for defendant/plaintiff information: the selection list comes from Codes table entries of type BkPtyCodes.

Case Upload

- The format of the statistics record has changed to include the new fields required by the Bankruptcy Reform Act (see Case Opening, above); additional edit checks are now being made. A chart identifying the fields and edit checks is included as Appendix 1.
- When a Chapter 7 case for an individual was uploaded, a value was required for "presumption" field (field 20) even when the nature of debt was "business"; now, a value is required only if nature of debt is "consumer".

Creditor Processing

- Creditor Maintenance/Upload a Creditor Matrix File
 - Additional checks are now being made to prevent bad data from being uploaded. Each line must begin with a letter, digit, or one of these characters: # % & @
 - Although the file was accepted, an error message was displayed when the path plus name of the matrix file exceeded 40 characters. This no longer occurs.

Docketing

- If the case has been converted or dismissed, the appropriate labeled date is now displayed with the case number at the top of the docketing screen.
- <u>Trustee's 341 Filings</u>: a trustee was able to make entries for a case in which he was no longer active. Now, only active trustees can make entries.
- Notice of Electronic Filing
 - ➤ Previously, any recipient of an NEF was allowed one view of referenced documents without incurring PACER charges. Now, only participants in the case (parties and attorneys) are given a "free look" while others will be billed.

Query

• When multiple cases are listed, the date closed is displayed in addition to the date filed.

Reports

- For a public user, these reports now display a warning that they are not subject to the 30-page cap on PACER charges: (1) Cases, (2) Claims Activity, and (3) Docket Activity.
- Cases: the old chapter is now shown for a converted case.

• Claims Register

- When a claim was amended but no document was attached, there was no "silver ball" to display the receipt for the amendment transaction on the Claims Register. This has been corrected.
- > The numbering of amended claims was different on a register produced by a court user than on one produced by a PACER user. This is corrected by a Codes table setting.

Docket Report

- The chapter of the related bankruptcy case is now shown for an adversary proceeding.
- > The entry for a claim transfer that was recorded via an ADI transaction did not have a "silver ball" to view the receipt. This has been corrected.

Utilities

Maintain Your ECF Account

A public user is no longer able to change their login name.

• Court Information

This new utility provides some general information for users, especially filing attorneys and PACER users, such as the maximum size of PDF files and the court's phone number; there is an option to "View as XML" (the XML data is in order by the tag name, which is a different order than the displayed HTML). A link for this utility also appears on the CM/ECF "Welcome" page. Appendix 2 provides a screen shot of the Court Information report, and a list of the data fields included in the report.

Miscellaneous

PACER

There is now an option to make the entry of client code mandatory; a required format may be defined. These items are specified by the user for their PSC account.

After a CM/ECF user has designated a default PACER account, logging in to CM/ECF causes the PACER login process to happen automatically; the user does not expect to be asked for a PACER login when running a billable report. However, if client code has been made mandatory for the default PACER account, the automatic login to PACER will not occur without a client code; if he has <u>not</u> typed a client code on the CM/ECF login screen, the PACER login screen will be displayed when the user runs a report.

- ➤ PACER users can now choose whether or not to display the PACER receipt. This item is specified by the user for their PSC account.
- ➤ The login screen presented to outside users has been changed to emphasize the differences between CM/ECF and PACER logins.
- ➤ PACER users are now authenticated at a central PSC location rather than in each court.
- The IP address of the PACER user is now included in the billing transaction file.
- ➤ User passwords containing a tilde were not being accepted. This has been corrected.


