7. Budget Narrative

Total project costs equal \$93,459, of which \$44,554 is non-Federal in-kind match, and \$48,905 is the requested Federal amount. The Budget Categories, Section B, of Standard Form 424A, are detailed as follows:

A. Personnel

The Federal costs include: 5% of Project Director's time, one Student Assistant at \$10/hour for 250 hours, and eight Student Leaders at \$800 each. The non-Federal match includes: Elizabeth Jane @ 25% time, Project Coordinator @ 10% time, Salinas Creek Coordinator @ 15% time, School Greenhouse Coordinator @ 15% time, Facilitator of workshop wage, and 1 student assistant for outreach @ 45 wks x 20hrs/wk.

B. Fringe Benefits

The Federal costs include: Project Director fringe benefits @ 35%, Student Assistant benefits @ 11%, Student Leaders @ 11%. The non –Federal match includes: staff time @ 11% (base of \$31,154) and Elizabeth Jane @ 35%.

C. Supplies

The Federal costs include: Printing and copying of workshop materials; LiMPETS curriculum, monitoring books, field guides for 20 teachers; monitoring equipment (outlined in detail below). The non-Federal match includes: books for background information on monitoring the rocky intertidal at \$25 each for 20 teachers.

D. Other
