In August 1999 in Phoenix, a shoot out between kidnapers and smugglers left three persons dead, including a 15-year old boy. AVILA is the last kidnapper sought in connection with the case. Following a trial that consumed almost three months, AVILA's five co-defendants were convicted in March 2001. Each defendant was sentenced to 16 life terms plus 235 years.
