

**AMERICAN FORK CANYON/ALPINE LOOP
RECREATION FEE PROJECT ACCOMPLISHMENTS:**

- Maintenance of 90 miles of system motorized, equestrian, hiking, and biking trails.
- Operation and maintenance of 5 picnic areas, 2 interpretive sites, 2 fishing sites, 1 observation site, 7 dispersed camping sites, 2 winter cross-country ski sites, and 14 trailheads.
- Security, compliance, education, and information patrols conducted by Forest Service personnel,
- New posters and signs for campgrounds, picnic areas, trailheads, and roads.
- Plowing, maintaining trailheads, cleaning facilities, and grooming cross country ski trails.
- Ongoing Grooming of snowmobile trails.
- Maintaining and fostering Recreation Fee partnership with National Park Service (Timpanogos Cave National Monument), Utah County (Sheriffs and Search and Rescue), Utah Department of Transportation, and Utah Division of State Parks and Recreation (Wasatch Mountain State Park).
- Supplementing extensive volunteer program in American Fork Canyon.
- Initiation of reconstruction of Little Mill campground.
- Implementation of Sawmill picnic area construction.
- Finished the Aspen Grove .5 mile trail re-route and bridge replacement project.
- Recreation personnel for FY06 included, 4 Forest Protection Officers, 2 wilderness rangers, 8 person trail crew, 6 Person developed maintenance crew, 6 person recreation fee crew.
- Updated signing on the Great Western Trail within American Fork Canyon.
- Continuance of sign replacement on all trail systems within American Fork Canyon.
- Completed installation of foot bridge at Granite Flat campground.
- Supplemented Timpanogos Cave National Monument programs and operations.
- Supplemented UDOT operations and maintenance in American Fork Canyon.
- Supplemented Utah County Law Enforcement operations in American Fork Canyon.
- Supplemented Wasatch Mountain State Park for grooming operations in American Fork Canyon.

Planned use of revenue

- Reconstruction of the Grey Cliffs and Echo picnic area reconstruction.
- Winter recreation operations and maintenance program.
- Operations and maintenance of developed and dispersed recreation sites, trailheads, and patrol and maintenance of wilderness and backcountry trails.
- Work with Utah Department of Transportation to reduce hazard trees and place barrier rock along SR-92 corridor in American Fork Canyon.

- Work closely with our partners, National Park Service, Utah Department of Transportation, Utah County Sheriffs, Wasatch Mountain State Park, local law enforcement, local City and County Governments, the Timpanogos Emergency Response Team, Search and Rescue, and our publics and recreation users.
- Administer approximately 51 special use permits.
- Winter recreation operations and maintenance program.
- Repair the water tank to supply Mount Timpanogos Campground.
- Aspen Grove trailhead rehabilitation project. Consolidation of a number of social trails into one or two branch trails to access the main trail into the Mt. Timpanogos wilderness area, placement of a bulletin board and re-vegetation of the existing social trails.
- Timpooneke Trailhead rehabilitation project. Consolidation of a number of social trails into one or two branch trails to access the main trail into the Mt. Timpanogos Wilderness area, placement of a bulletin board and re-vegetation of the existing social trails.
- Finish reconstruction of Little Mill Campground.
- Finish Sawmill picnic area construction.
- Continue updating the trail signs, trailhead kiosks, Recreation Fee information, and campground and picnic area signs and bulletin boards.
- Upgrades to Mount Timpanogos campground that includes installation of new fire rings.
