
Dear Mr. Johnson:

OFHEO's deficient milestone was to educate appropriate employees on the process for posting materials to OFHEO's website as required under subsection (a)(2) of the Freedom of Information Act, as amended. ## FOIA UPDATED STATUS REPORT

July 31, 2007

### 1. Improvement Plan Area

Affirmative disclosure under subsection (a)(2) of the Freedom of Information Act, as amended.

### 2. Deficient Milestone

Educate appropriate employees on the process for posting materials to OFHEO's website as required under subsection (a)(2) of the Freedom of Information Act, as amended.

Original target date: December 31, 2006

### 3. Steps Taken to Correct the Deficiency

The deficient milestone is corrected. On March 2, 2007, Associate Directors and Office Directors were educated on the process that will be implemented to keep OFHEO's electronic reading room current. They were provided a copy of the contents list for the electronic reading room and asked to review the documents that will be included on OFHEO's new website.

The contents of the electronic reading room will be reviewed quarterly and will include: orders made in the adjudication of cases; statements of policy and interpretations which have been adopted by OFHEO and are not published in the Federal Register; policies and administrative manuals that affect a member of the public; copies of all records, regardless of form or format, which have been released to any person under FOIA and which, because of the nature of their subject matter, OFHEO determines have become or are likely to become the subject of subsequent requests for substantially the same records. Documents in the reading room will be indexed as appropriate.

### 4. Additional Future Steps to Correct the Deficiency

No additional steps are needed. The deficiency is corrected.
