"Parties in interest" in an adversary proceeding means: The plaintiff and/or their attorney, the defendant and/or their attorney, U.S. Trustee, and any objecting party or attorney who may be directly involved with the proceeding should receive notice.
- 3. Fees not all inclusive. Refer to Bankruptcy Court Miscellaneous Fee Schedule for filing fees and exceptions to filing fees. Title 28, § 1930.
- 4. "All Creditors" means: Everyone on the mailing matrix, parties in interest, plus any other attorney or objecting party who is not listed but might be a party in interest.
- 5. Cover Sheet is required when the proceeding is not filed electronically.
