
# Why Standards?

#### Purposes

- Eliminate billions of dollars of wasteful IT spending
- Reduce paperwork burden on citizens & businesses
- Improve response time to citizens
- Guiding Principles
  - Citizen-centered not bureaucracy or agency-centered
  - Results-oriented measurable improvements for citizens
  - Market-based actively promoting innovation

# OMB Circular A-119

Voluntary Consensus Standards (VCS)

- Use VCS in lieu of government-unique standards
- Reduce reliance on government-unique standards
- Avoid discrimination among private sector standards
- However, some of the LOBs & eGov projects are –Specifying gov-unique data standards –Dictating use of proprietary software
- VCS examples include XML & XBRL
- Specify XML schemas & let citizens & businesses use whatever software *they* choose

## **OMB Circular A-76**

Inherently Governmental Versus Commercial Activities

- Certain functions are inherently Governmental in nature, being so intimately related to the public interest as to mandate performance only by Federal employees
- The Federal Government shall rely on commercially available sources to provide commercial products and services

#### OMB Circular A-76 My Assertions

- Determining the data requirements to conduct "We the People's" business is an inherently governmental function
- Whenever possible, commercial and industrial standards should be used; however ...
- To the degree that such data standards may not exist or are inconsistent with each other, it is incumbent upon government officials to specify them as soon as possible
  - Not only within but also across LOBs & eGov projects
  - To achieve "citizen-centered" standardization
  - Example: XBRL taxonomies for .gov regulatory reports

# FEA Data Reference Model

Toward Citizen-Centered Data Standardization

- Governmentwide Data Standarization Areas
  - Description
  - Context (Taxonomies)
  - ► Sharing
- XML Schema
  - Enable Sharing of DRM Metadata
- Discovery, Access & Use of Government Records
  - Querying Elements of DRM Metadata
  - Browsing Context/Taxonomies
- Data "Harmonization"
  - Standardization
  - Authoritative Sources
  - ► "Mapping"

- Open standards to enable the organization and categorization of Government information
- Searchable electronically by unique identifiers
- Definition of categories of Government information
- .gov XBRL taxonomies as authoritative sources in DRM

- Service Interface & Integration
  - Interoperability
    - Data Format/Classification
      - ★ Extensible Markup Language (XML)
- Component Framework
  - Data Management
    - Reporting & Analyses
      - ★ Extensible Business Reporting Language (XBRL)
- Agencies should take these VCS into account in their enterprise architectures (EA), IT modernization transition plans, and capital planning & investment (CPIC) processes
